RELEASE FROM LIEN OF MORTGAGE

Know All Men By These Presents, That, the undersigned Mattie Lou Hodge does hereby release the hereinafter particularly described property from the lien of that certain mortgage executed by Maria Campbell and William C. Yon which said mortgage was recorded in the office of the Judge of Probate Court of Shelby County, Alabama, in Mortgage Book No. 323, Page No. 704, and for said consideration, the receipt of which is hereby acknowledged, the undersigned does hereby release, remise, quit claim and convey unto Maria Campbell and William C. Yon, all of the right, title and interest of the undersigned in and to the following described property situated in Shelby County, Alabama to-wit:

Commencing at the NE corner of the NE1/4 of NW1/4 of Section 2, Township 20 South, Range 1 West, run South along the East line of said 1/4-1/4 Section to a Shelby County Gravel Road; thence in a Northwesterly direction along the center line of said gravel road a distance of 175 feet, more or less, to an intersection with an old logging road; thence run in a Southerly direction along the center line of said old logging road as it meanders for a distance of 263 feet, more or less, to the point of beginning; thence begin at the center line of said old logging road run thence in a Southerly direction along said center line as it meanders for a distance of 475 feet more or less to a point in the center line of said old road being at the South edge of a cleared field; thence West and parallel with the North line of said 1/4-1/4 Section to a point in the middle of the Yellow Leaf Creek; thence in a Northwesterly direction along the center of said creek a distance of 300 feet more or less; thence Northerly direction a distance of 200 feet to a metal stake marking the Northwest corner; thence at an angle of 91 deg. 26' in an Easterly direction a distance of 310 feet, more or less, to point of beginning. Situated in Shelby County, Alabama.
