I, Colin Reid Campbell, a resident of Baltimore City, State of Maryland, being of sound mind and disposing memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other wills and codicils thereto heretofore made by me.

ITEM ONE: I direct that all of my debts, including the expenses of my last illness and funeral, shall first be paid out of my estate by my executor hereinafter named, as soon as practicable after my death.

ITEM TWO: I give, devise and bequeath all of my property, of whatever kind and character and wherever situated, to my wife, Margaret Perry Campbell, absolutely, if she survives me.

ITEM THREE: If my wife does not survive me, then all the rest, residue and remainder of my property, of whatever kind and character and wherever situated, excluding any property over which I am given a power of appointment under the will of my wife (which power I specifically decline to exercise) I give, devise and bequeath to my children, Maria Bouchelle Campbell and Colin R. Campbell, Jr. in equal shares, if they both survive me, or to the survivor of them if only one survives me.

ITEM FOUR: If I am survived by neither my said wife nor any descendant of me, I give, devise and bequeath my property to such persons as would be entitled to inherit said property and in the proportions in which they would be entitled to inherit the same, from me under the laws of Maryland in force at the time of my death, as if I had died a resident of Maryland intestate, unmarried and owned said property.

ITEM FIVE: I hereby nominate and appoint my wife, Margaret Perry Campbell, as executrix of this my last will and testament. If my said wife does not survive me or fails or refuses to act as executrix, or, having acted, should thereafter die, resign or become incapacitated, then I nominate and appoint my daughter, Maria Bouchelle Campbell, as my executrix. If my said daughter does not survive me or fails or refuses to act as executrix, or, having acted, should thereafter die, resign or become incapacitated, then I nominate my son, Colin Reid Campbell, Jr., as my executor. I direct that my executor acting at any time hereunder shall not be required to give bond or to file an inventory or appraisal of my estate in any court. My executor shall hold and manage all property in my estate and such other property as my executor may subsequently acquire pursuant to the power and authority herein given to him or her (all of which for convenience will hereinafter be referred to as "Property"), with full power to collect the income therefrom and from time to time to sell, convey, exchange, lease for a period beyond the possible termination of the administration of my estate, or for a less period, improve, encumber, borrow on the security of, or otherwise dispose of, all or any portion of said Property, in such manner and upon such terms and conditions as my executor may approve, and with full power to invest and reinvest said Property and the proceeds of sale or disposal of any portion thereof, in such loans, stocks, bonds or other securities, mortgages, common trust funds, or other property, real, personal or mixed, as to my executor may seem suitable, and to change investments and to make new investments from time to time as to my executor may seem necessary or desirable. My executor may continue to hold any property or securities originally received by him or her as a part of my estate, so long as he or she shall consider the retention thereof for the best interests of my estate, regardless of whether such property constituting a part of said Property, my executor may acquire other property not a so-called "legal" investment where such course is in his or her opinion for the best interests of my estate. My executor shall have power to determine whether any money or property coming into his or her hands shall be treated as principal or income,
