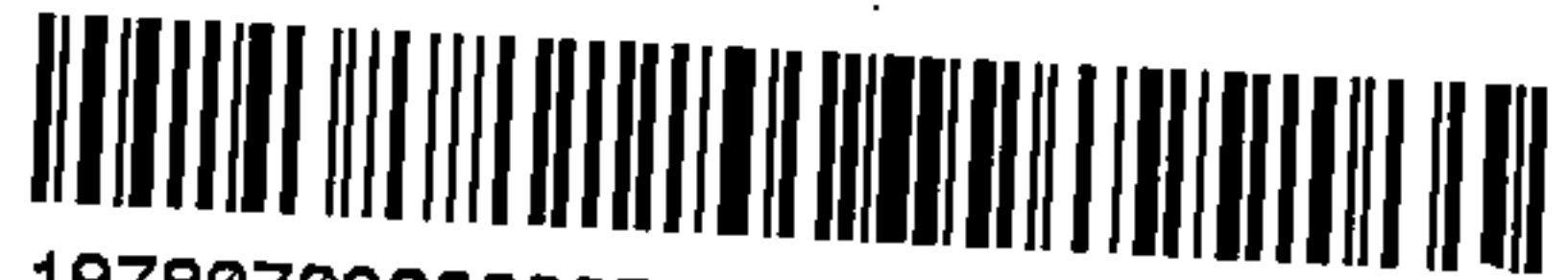

Part of the Northeast quarter of Northwest quarter, Section 2, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

From the Southwest corner of lot 12, Royal Oaks 1st Sector, a map of which is recorded in Map Book 7, Page 17, in the Office of the Judge of Probate, Shelby County, Alabama, looking in a northerly direction along the west line of said Lot 12, turn an angle to the left of 71 degrees 00 minutes and run in a northwesterly direction for a distance of 209 feet, thence turn an angle to the left of 66 degrees 55 minutes 30 seconds and run in a southwesterly direction for a distance of 240 feet; thence turn an angle to the left of 5 degrees 10 minutes and run in a southwesterly direction for a distance of 316.67 feet; thence turn an angle to the right of 71 degrees 40 minutes 36 seconds and run in a northwesterly direction for a distance of 206.75 feet to the point of beginning; thence turn an angle to the right of 180 degrees 00 minutes and run in a southeasterly direction for a distance of 206.75 feet; thence turn an angle to the right of 108 degrees 19 minutes 24 seconds and run in a southwesterly direction for a distance of 36.50 feet; thence turn an angle to the left of 9 degrees 56 minutes and run in a southwesterly direction for a distance of 74.52 feet; thence turn an angle to the right of 62 degrees 11 minutes 36 seconds and run in a westerly direction for a distance of 134 feet to the beginning of a curve which is concave in a northeasterly direction, said curve having a central angle of 90 degrees 00 degrees and a radius of 15 feet; thence turn an angle to the right and run along the arc of said curve for a distance of 23.56 feet to the end of said curve; thence run in a northerly direction along a line tangent to end of said curve for a distance of 82 feet to the beginning of a curve which is concave in a easterly direction, said curve having a radius of 204.64 feet; thence turn an angle to the right and run along the arc of said curve for a distance of 67.74 feet, more or less, to the point of beginning.
