KNOW ALL MEN BY THESE PRESENTS, That whereas, I, Kyle Lansford, Register of the Circuit Court of said County in said State, in that certain cause filed by K.B. All that part of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 7, Township 18, Range 2 East, lying North and East of a public road, leading from Vandiver to Pell City, containing three (3) acres, more or less, situated in Shelby County, Alabama.

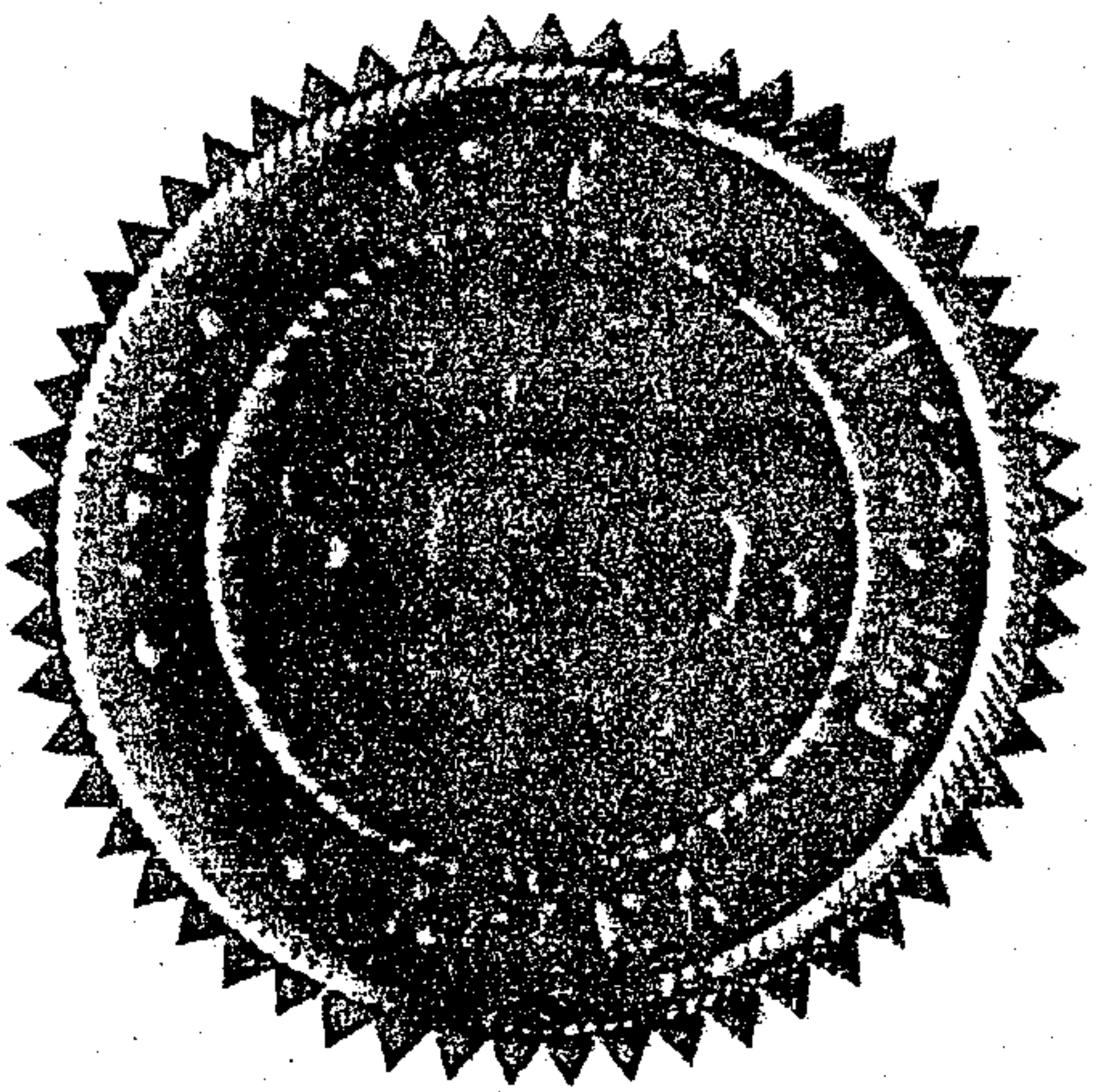
