

REGISTER'S DEED

KNOW ALL MEN BY THESE PRESENTS, That whereas, I, Kyle Lansford, Register of the Circuit Court of said County in said State, in that certain cause filed by K.B. Howard, Plaintiff, against Floyd Howard, Jr., Tommy Howard and David Howard, Defendants, in pursuance to the law in such cases made and provided, and strictly in accordance with all and singular the terms and requirements of the order and decree of said Court on the // day of May, 1978, whereas under said Decree the hereinafter described lands were ordered to be sold by the Register of the Circuit Court of Shelby County, Alabama, at public outcry to the highest bidder for cash in front of the Courthouse door of said County after having been duly advertised by publication for four (4) consecutive weeks in SHELBY COUNTY NEWS, a newspaper published in Shelby County, Alabama, and whereas, under and in pursuance to the Order and Decrees of said Court directing said sale and in strict compliance with said Orders and Decrees, said lands were sold by me as a Register of said Court to Roy Partridge and wife, Ruby Partridge, they being the highest and best bidders at said sale and became the purchasers of the real estate hereinafter described for the sum of Four Thousand and no/100-----Dollars (\$4,000.00).


