angle of 90 deg. 0 Min. 0 Sec. to the right and run for a distance of 116 ft.  
Thence turn an angle of 90 deg. 0 Min. 0 Sec. to the right and run for a  
distance of 221 feet to a point on the Southeast R/W line of above stated hwy.  
Thence turn an angle of 78 deg. 13 min. 54 sec. to the right and run a distanc
