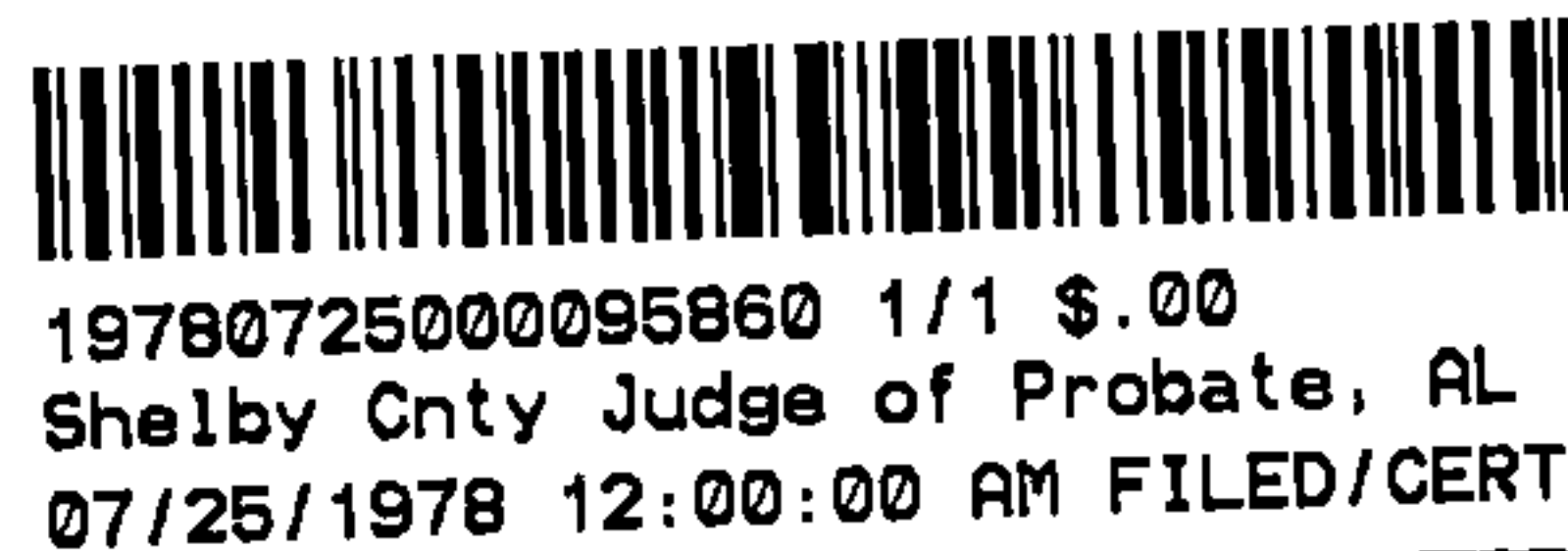

KNOW ALL MEN BY THESE PRESENTS, THAT, for and in consideration of SIXTEEN THOUSAND FOUR HUNDRED FORTY-FIVE DOLLARS (\$16,445.00) principal payment with interest on the unpaid balance in the amount of ONE THOUSAND TWO HUNDRED SEVENTEEN and 52/100 DOLLARS (\$1,217.52) paid to William P. Buck and wife, Jane B. Buck, hereinafter called "Grantor", by Emmett W. Cloud and wife, Margaret B. Cloud, hereinafter referred to as "Grantee", receipt of which is acknowledged, the said Grantor does hereby remise, release, quitclaim, and convey unto the said Grantee, the following described land, MINERALS AND MINING RIGHTS EXCEPTED:

Part of Lot 3 (2.53 acres), in the Survey of Windwood Circle Residential Subdivision as recorded in Map Book 6, Page 154, in the Office of the Judge of Probate of Shelby County, Alabama.

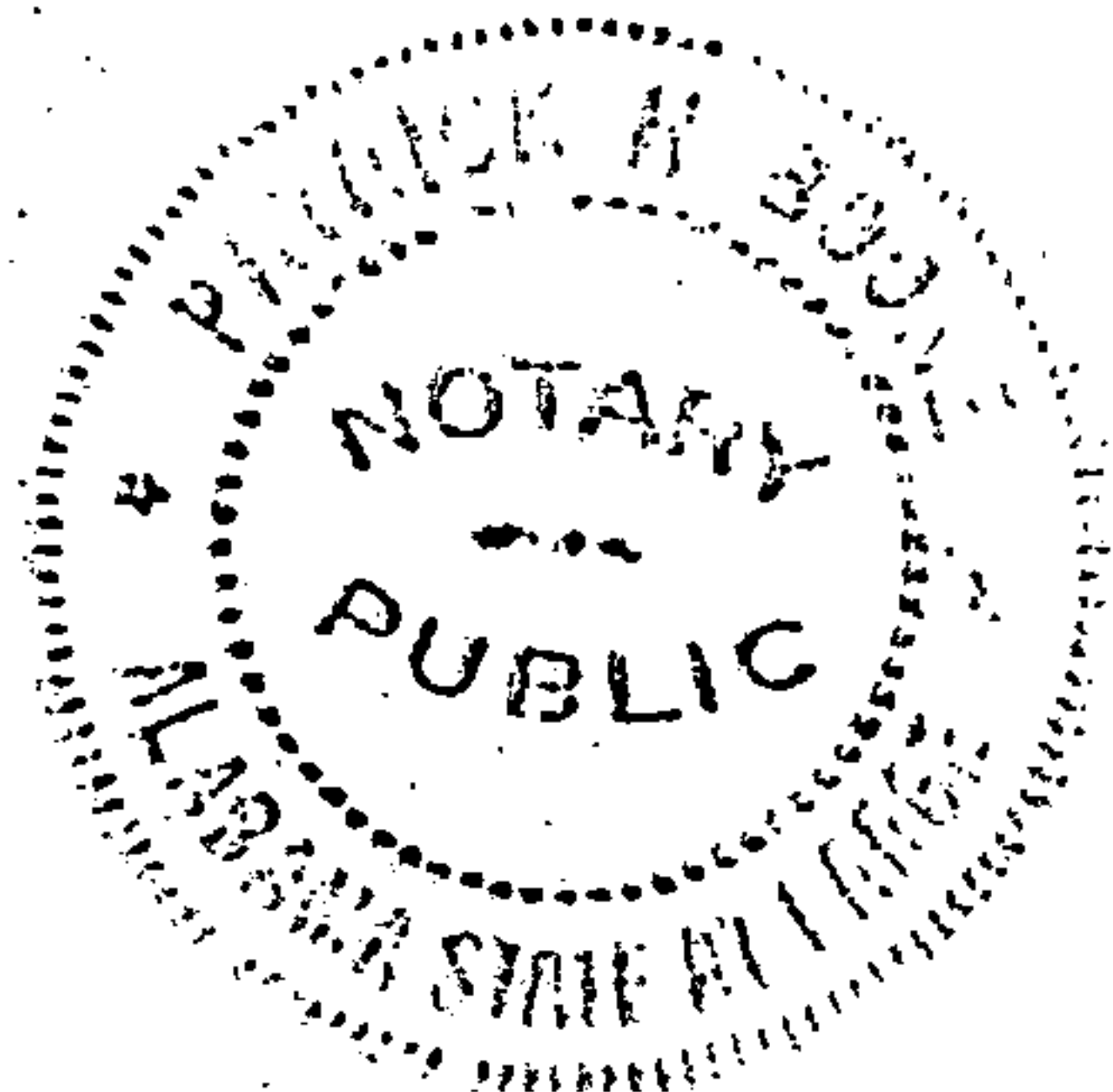
