said GRANTOR does by these presents, grant, bargain, sell and convey unto

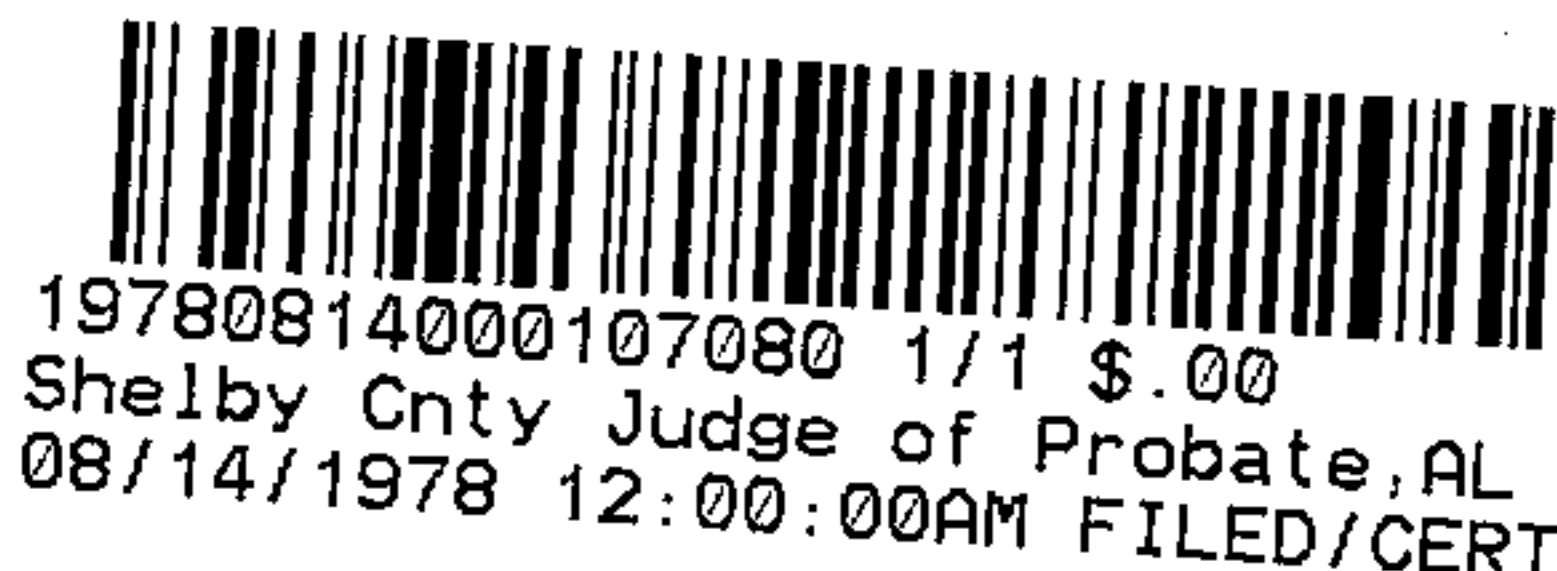
John C. Connor and wife, Jean M. Connor
