Hawk, recorded in Book 276, Page 632, of the land mortgage records of Shelby County, Alabama, does hereby release from said mortgage/deed of trust the following:

A lot or parcel of land located in the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Sec. 21, Tp. 19S, R. 2 E and being more particularly described as commencing at the intersection of the W. line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Sec. 21 and the Northerly right-of-way of County Road No. 62; thence N. 0 deg. 41 min. W. along the W. line of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of said Sec. 21, 661.8 ft. to the place of beginning; thence from the place of beginning and continuing along the W. line of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of said Sec. 21, 394.5 ft; thence N. 89 deg. 19 min. E. 201.54 ft; thence S. 0 deg. 41 min. E. and parallel to the W. line of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of said Sec. 21, 340.0 ft; thence S. 74 deg. 10 min. W. 208.8 ft. to the place of beginning and containing 1.76 acres, more or less.

ALSO: A 20 foot ingress and egress easement along the W. line of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of said Sec. 21 and being more particularly described as beginning at the intersection of the Northerly right-of-way line of Shelby County Highway No. 62 with the W. line of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of said Sec. 21; thence N. 0 deg. 41 min. W. along the W. line of said Quarter Sec. 661.8 ft; thence N. 74 deg. 10 min. E. 20.8 ft; thence S. 0 deg. 41 min. E. and parallel to the W. line of said Quarter Sec. 657.8 ft. to the Northerly right-of-way line of said road; thence S. 64 deg. 01 min. W. along the Northerly right-of-way line of said road 22.2 feet to the place of beginning.

Except as hereinabove provided, said mortgage shall remain in full force and effect.

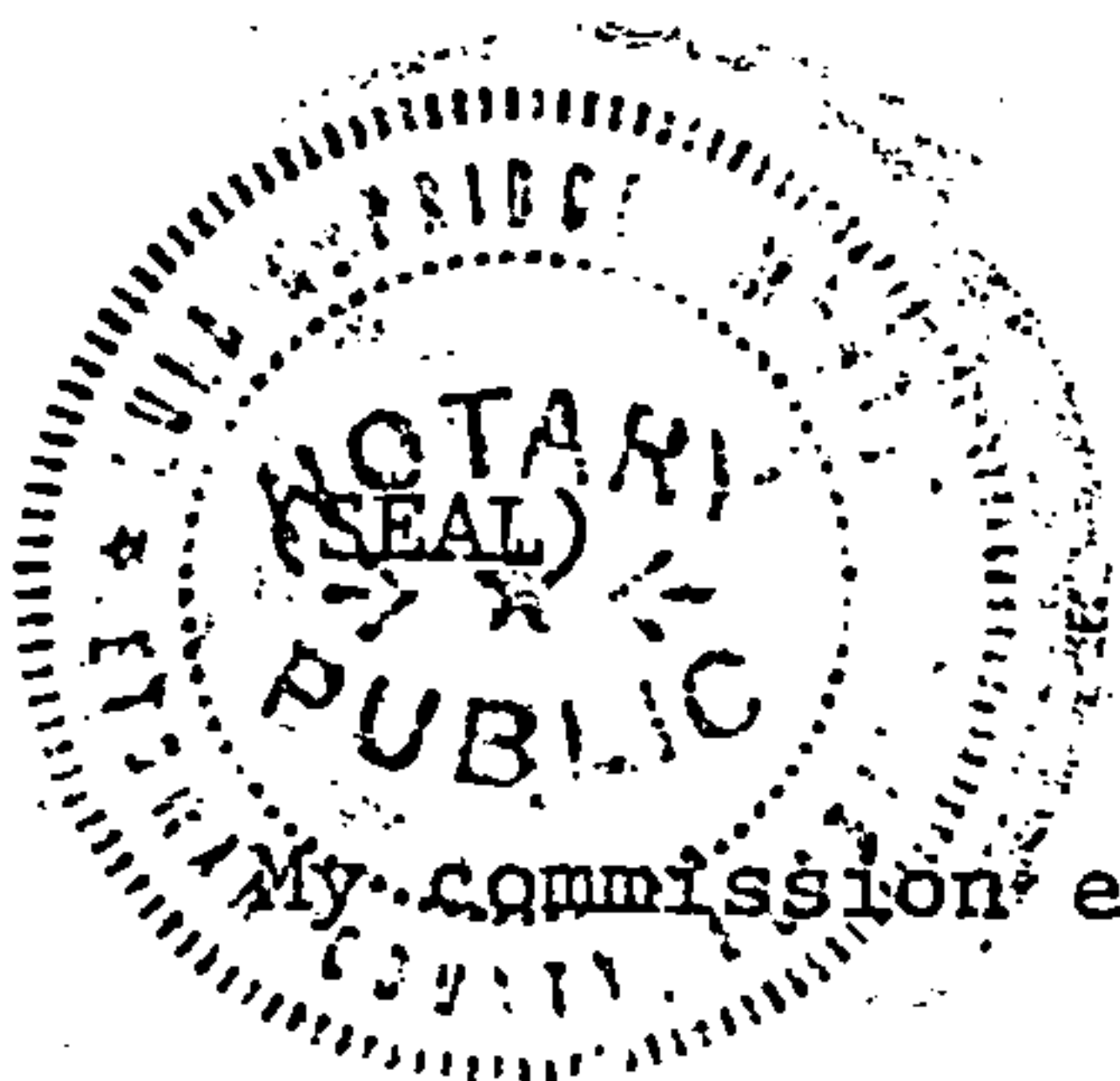
