That in consideration of One Dollar (\$1.00) and other good and valuable consideration to the undersigned grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Bert N. Adams, William W. Adams, Jr. and Commercial Bank of Liberty, N.A., trustees under Trust Agreement dated August 19, 1977, of which William W. Adams, Sr. was grantor, of Clay County, Missouri (herein referred to as grantors) do grant, bargain, sell and convey unto

William W. Adams, Jr. and Eleanor Ruth Adams, husband and wife, of Liberty, Clay County, Missouri, and Bert N. Adams and Diane Betts Adams, husband and wife, of Madison, Dane County, Wisconsin, (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

A nine-thirty seconds (9/32) undivided interest as tenants in common in the property legally described as the:
