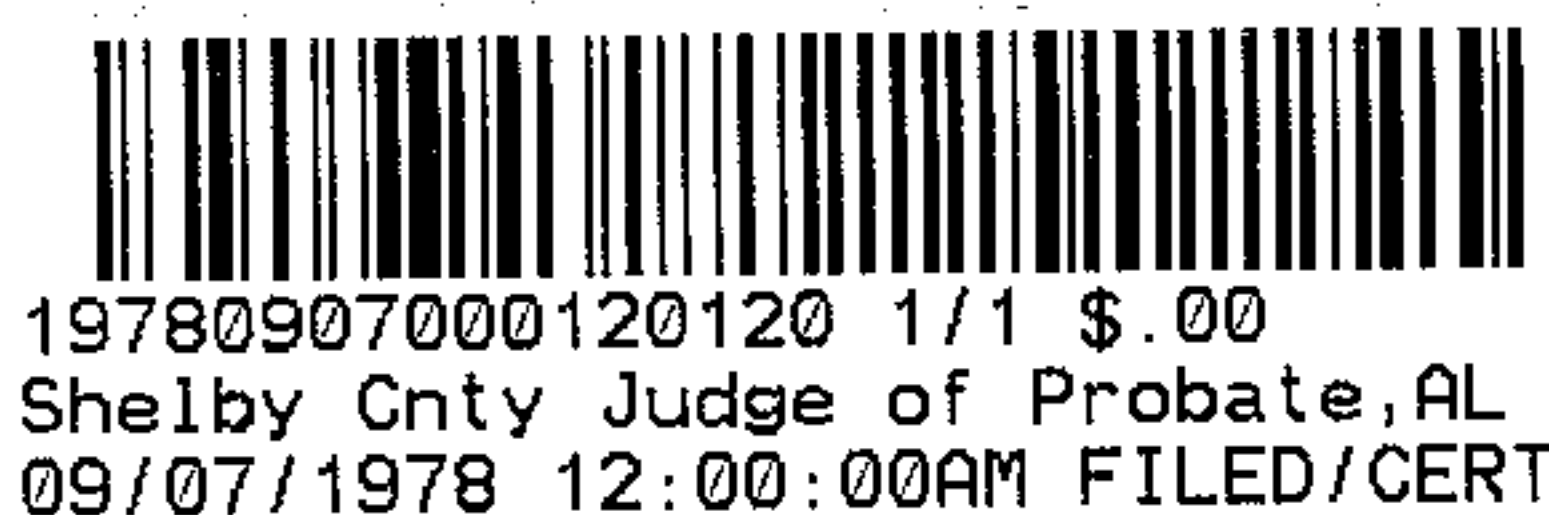
the receipt of which is hereby acknowledged, the said W.M. Humphries Enterprises, Inc.
