

conveyed therein, and described as follows, to-wit:

Commence at the NW corner of the NW of the NE of Section 3, Township 20 South, Range 2 East, Shelby County, Alabama; thence proceed North 89 deg. 54 min. East along the North boundary of said $\frac{1}{4} - \frac{1}{4}$ section for a distance of 382.72 feet to a point on the Westerly rightof-way line of a Shelby County Paved Road (Chancellor Ferry Road); thence proceed South 29 deg. 04 min. East along the Westerly right-of-way line of said road for a distance of 2085.61 feet; thence turn an angle of 117 deg. 01 min. to the right and proceed South 87 deg. 57 min. East for a distance of 144.73 feet to a point on the Westerly boundary of an old field road and the point of beginning. From this beginning point continue South 87 deg. 57 min. East for a distance of 250 feet; thence turn an angle of 90 deg. to the left and proceed South 2 deg. 03 min. East for a distance of 200 feet; thence turn an angle of 90 deg. to the left and proceed North 87 deg. 57 min. East for a distance of 99.72 feet to a point on the Westerly boundary of said field road; thence proceed North 53 deg. 35 min. East along the Westerly boundary of said field road for a distance of 142.02 feet; thence proceed North 23 deg. 25 min. East along the Westerly boundary of said field road for a distance of 53.49 feet; thence proceed North 5 deg. 57 min. East along the Westerly boundary of said field road for a distance of 72.2 feet to the point of beginning.

The above described land is located in the Southwest one-fourth of the Northeast one-fourth of Section 3, Township 20 South, Range 2 East, Shelby County, Alabama, and contains 0.95 acres.
