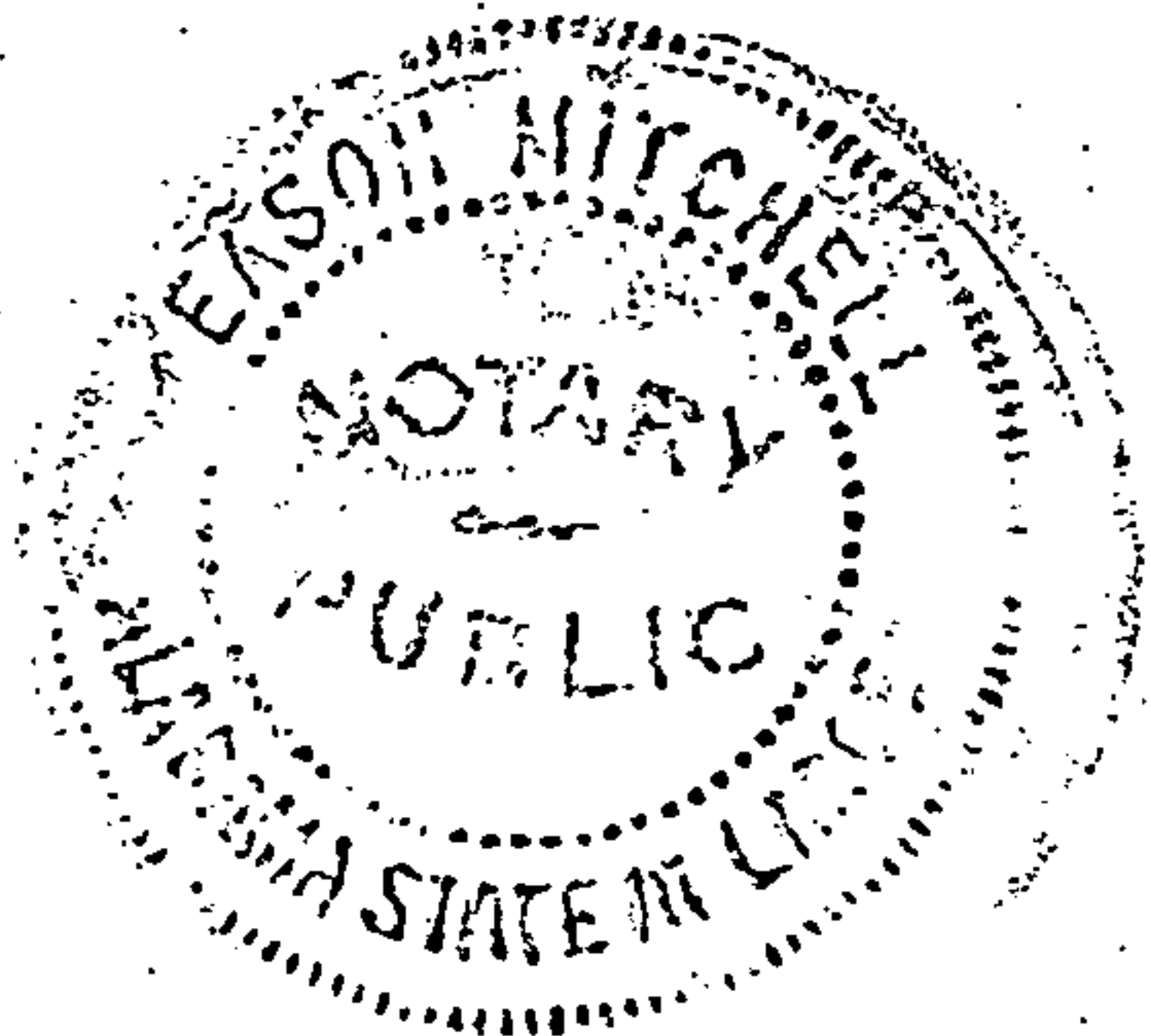
My wife, Louise, died December 23, 1972 and I have remarried. My present wife's name is Mary Lawley.

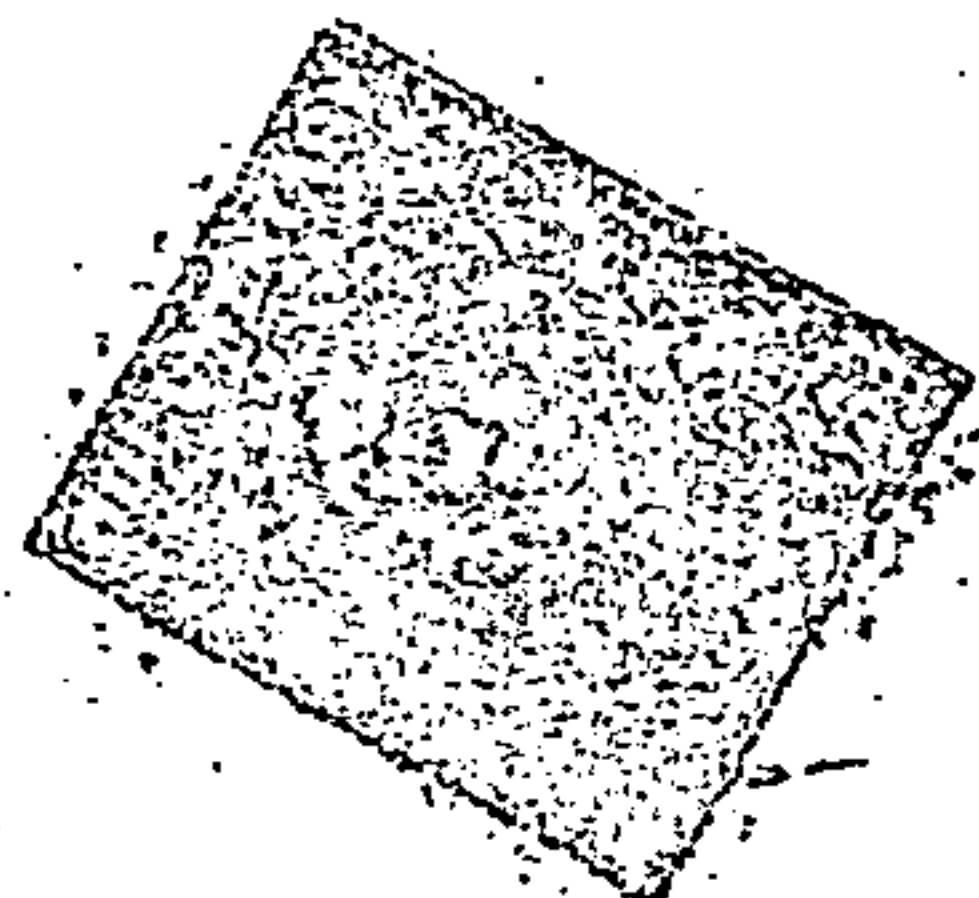
