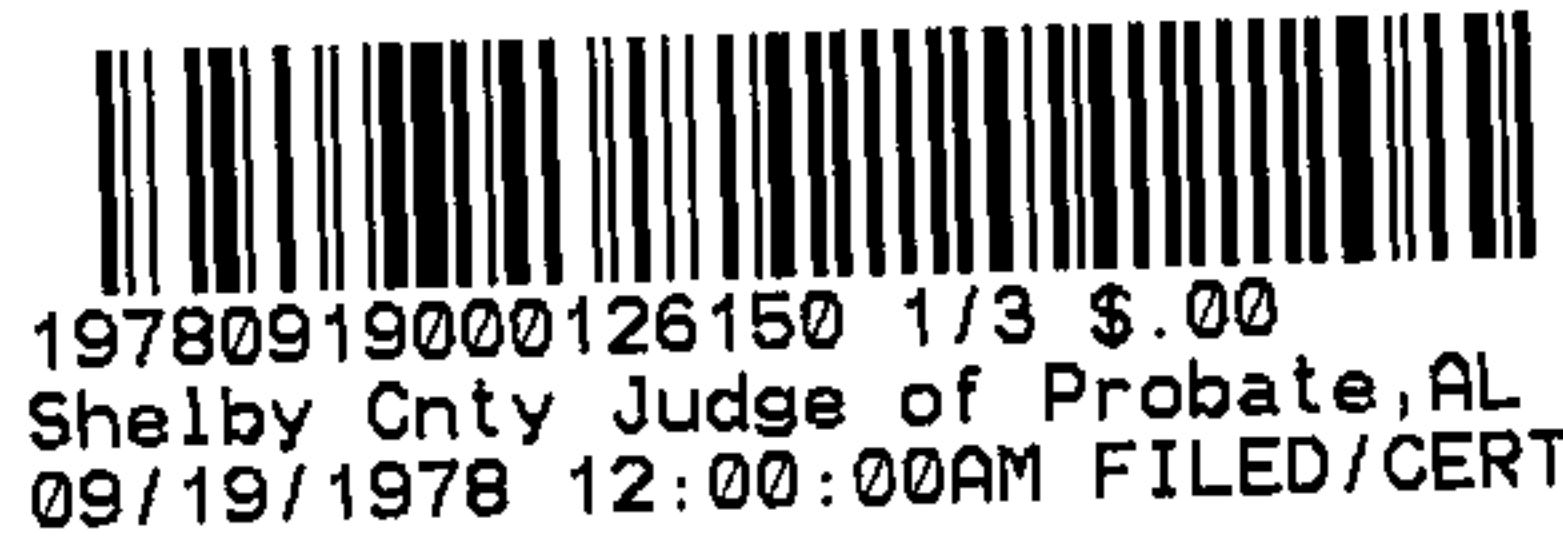

QUITCLAIM DEED

STATE OF ALABAMA )

KNOW ALL MEN BY THESE PRESENTS, that KIMBERLY-CLARK CORPORATION, a corporation, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, in hand paid by IDUMA MITCHEM, a widow, the receipt whereof is hereby acknowledged, does hereby remise, release, quitclaim and convey unto the said IDUMA MITCHEM, all its right, title, interest and claim in and to the following described real estate, situated in Shelby County, Alabama, to-wit:

PARCEL 1

That portion of the Northeast Quarter of the Northwest Quarter of Section 36, Township 19 South, Range 1 West, lying southwest of a County road, less and except the following described land:

Commence at the southwest corner of the Northeast Quarter of the Northwest Quarter of Section 36 and run north along the west boundary line of said quarter-quarter section a distance of 420 feet, more or less, to an iron stake, such point being the point of beginning; from such point of beginning, turn right and run east to a point on the southwest boundary line of said County Road; thence turn left and run northwest along said boundary line of said county road to a point on the west boundary line of said quarter-quarter section; thence turn left and run south along said boundary line to the point of beginning.

PARCEL 2

That portion of the Southwest Quarter of the Northeast Quarter and the Northwest Quarter of the Southeast Quarter of Section 36, Township 19 South, Range 1 West, lying west of a county road.

PARCEL 3

A 2.2-acre rectangle in the northeast corner of the Southeast Quarter of the Southwest Quarter of Section 36, Township 19 South, Range 1 West, approximately described as follows:

Begin at the Northeast corner of said quarter-quarter section and run west along the north boundary line of said quarter-quarter section a distance of 440 feet, more or less, to a rock corner; thence turn left and run south a distance of 230 feet, more or less, to a rock corner; thence turn left and run east to a point on the east boundary line of said quarter-quarter section; thence turn left and run north along said east boundary line to the point of beginning.

TO HAVE AND TO HOLD unto the said IDUMA MITCHEM, her heirs and assigns, forever.

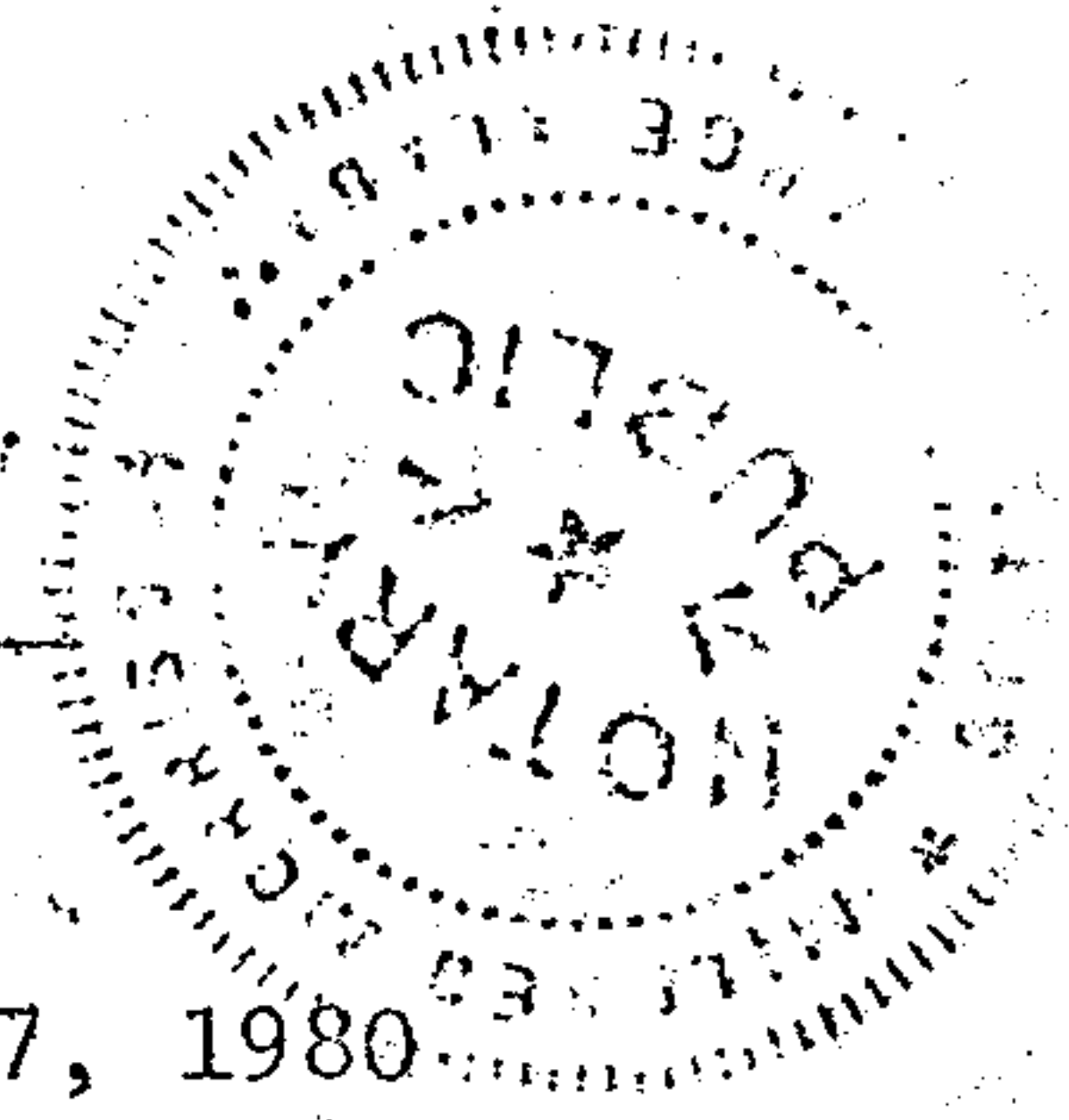
