Before me the undersigned authority, personally appeared Aaron B. Harris, who is known to me, and who being by me first duly sworn, deposes and says as follows:

My name is Aaron B. Harris. I am 26 years of age and reside at Montevallo, Shelby County, Alabama.

I am a son of Burr Harris, who died intestate on or about December 14, 1962, while a resident of Shelby County, Alabama.

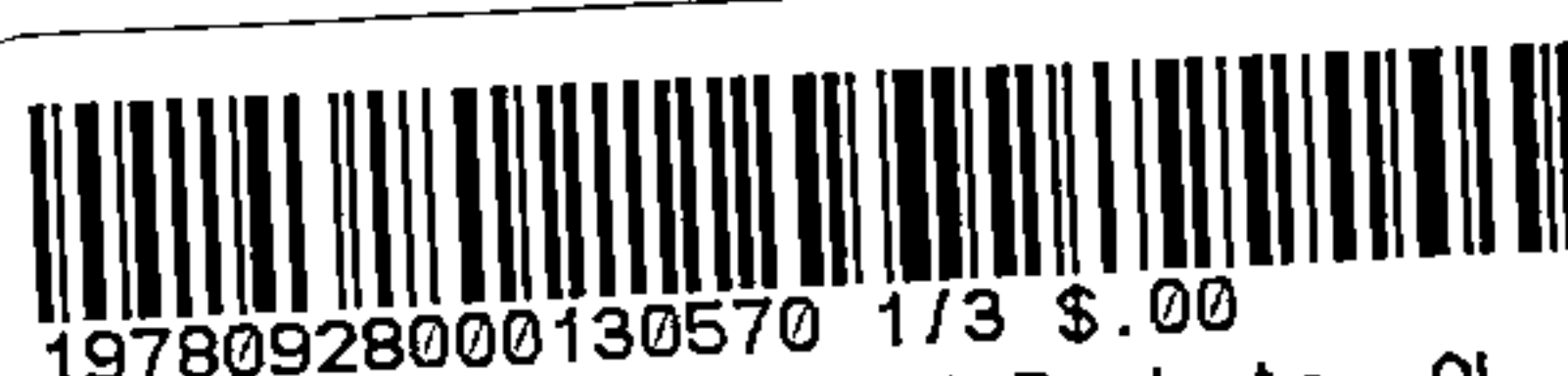
At the time of my said father's death, there appeared to be no necessity for having an administration of his estate, but later after the death of my mother, namely, Ethel Harris, who was the widow of my said father, which occurred on June 11, 1978, it was decided among members of my family that an estate should be opened for my said father in the Probate Court of Shelby County, Alabama, and I, as the son of my said father, petitioned the Probate Court and was granted Letters of Administration by the Probate Court of Shelby County on the estate of said Burr Harris, Deceased, on or about June 22, 1978.

No claims have been filed against the estate of my said father, as all of his debts have been paid many years ago. I do hereby state and certify that there are no claims or debts against my said father, or his estate.

My said father had only nine children, namely, myself, Aaron B. Harris, Harvey S. Harris, Virgil Harris, Joseph E. Harris, Mary E. Harris Allen, Joyce K. Harris Haynie, Betty J. Harris Holcomb, Vandora Harris Bunch, and William Harris; my said brother, William Harris, is deceased, he having only two children, namely, Billy Lane Harris and Larry W. Harris. My said father, Burr Harris, is not survived by any other children, or descendants of deceased children, except those persons specifically mentioned above in this paragraph.

I have been familiar with the ownership and possession of the following described property which is situated in Montevallo, Shelby County, Alabama viz.:

Beginning at the westernmost corner of the property belonging to Minnie P. Harvey the said point of beginning being the intersection of north boundary street and Island Street; thence running in a Northeasterly direction along the margin of said Island

Street a distance of 116 feet; thence in a Southeasterly direction 190 feet along the property belonging to Mrs. S. P. Harrell; thence in a Southwesterly direction a distance of 52 feet along the edge of Bess Woods property and thence in a Northwesterly direction along the margin of the Old Montgomery Road a distance of 222½ feet to the point of beginning. Located in the Town of Montevallo, Alabama, in the Storr's Addition to the Town of Montevallo, according to Dare's Survey and plot of said Storr's Addition which is recorded in the Probate Office of Shelby County, Alabama.

The property herein described is the real estate situated in Shelby County, Alabama, which was owned by Burr Harris at the time of his death, whether correctly described above or not,


for more than the past thirty years and/ <sup>since</sup> October, 1945, when my said father, Burr Harris, bought and went into possession of said property under his deed which is recorded in Deed Book 122 at page 98, Office of Judge of Probate of Shelby County, Alabama, ( my father's name in said deed being spelled "Burr Harriss").

My father and mother lived in a house situated on said property as their homestead from 1945 until the death of my said father, as stated above, and after the death of my said father, my said mother continued to live and reside on said property as her homestead until the time of her death, as stated above.


A portion of said property was acquired by the City of Montevallo by condemnation proceedings as shown in Probate Minutes 27 at page 739 and as shown in Deed Book 231 at page 57, Office of Judge of Probate of Shelby County, Alabama.


The property lines of said property are marked and defined on the ground, and, to my knowledge, there are no disputes concerning the boundaries of said property or the ownership thereof.

I know of my own personal knowledge that the above described property has been in the open, continuous, notorious, undisturbed, peaceable, exclusive, hostile, actual adverse possession of my said father, Burr Harris, and his successors in title, as designated above, since October, 1945, and until the present date.

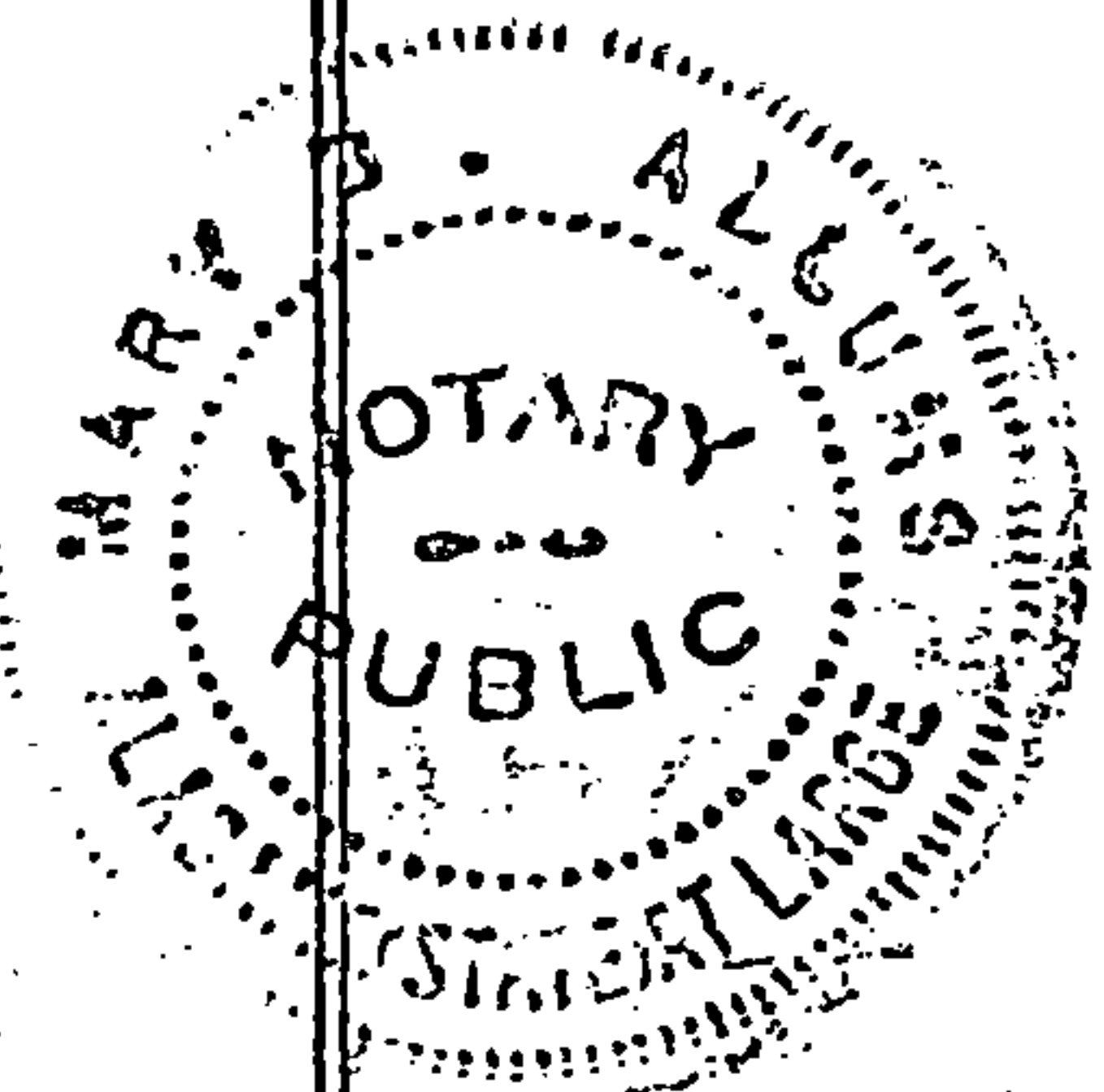
