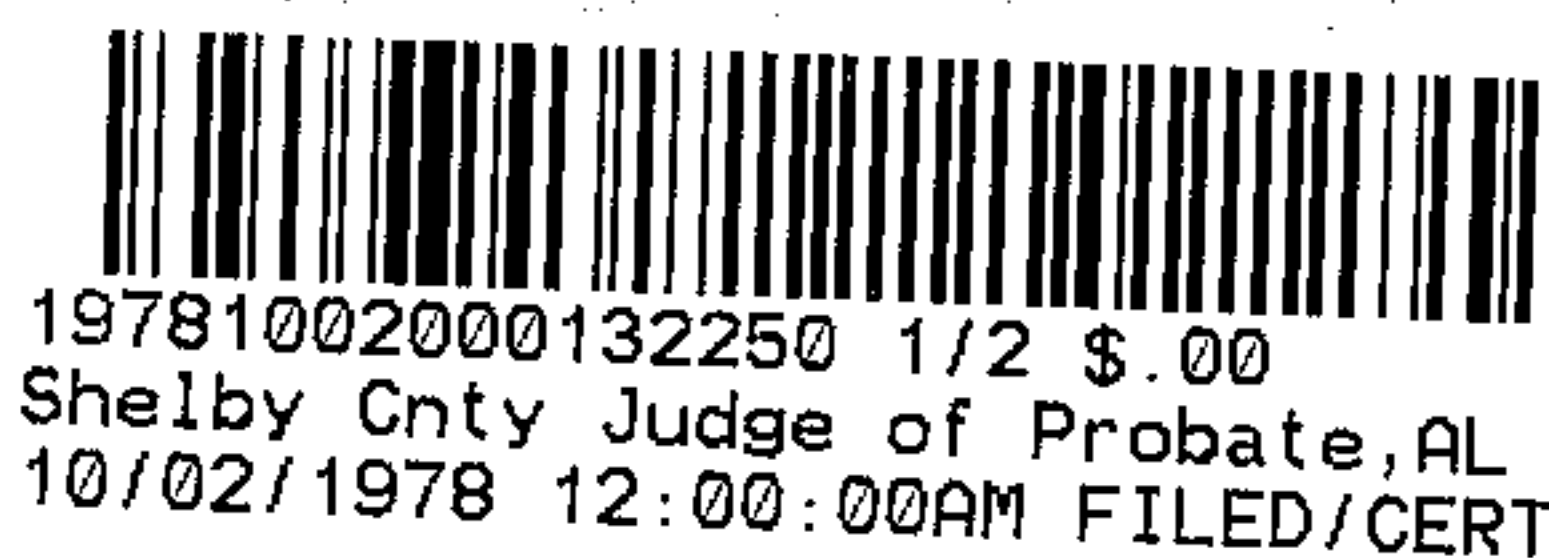

said Mary Ann Brown the following described real estate, to wit: Beginning at the Northeast corner of the Woody Donaldson and Annie May Donaldson property which lies west of the Southern Railway, in the Southwest quarter of the Northwest quarter, Section 17, Township 22, Range 3 West, and running in a westerly direction along the north line of the said Donaldson property a distance of 753 feet, thence in a northerly direction a distance of 444 feet to the south line of the W.E. Harrison tract of land, thence in an easterly direction along the south line of the Harrison tract a distance of 782 feet to the Southern Railway right of way, thence in a southerly direction along the said right of way a distance of 683 feet to the point of beginning.
