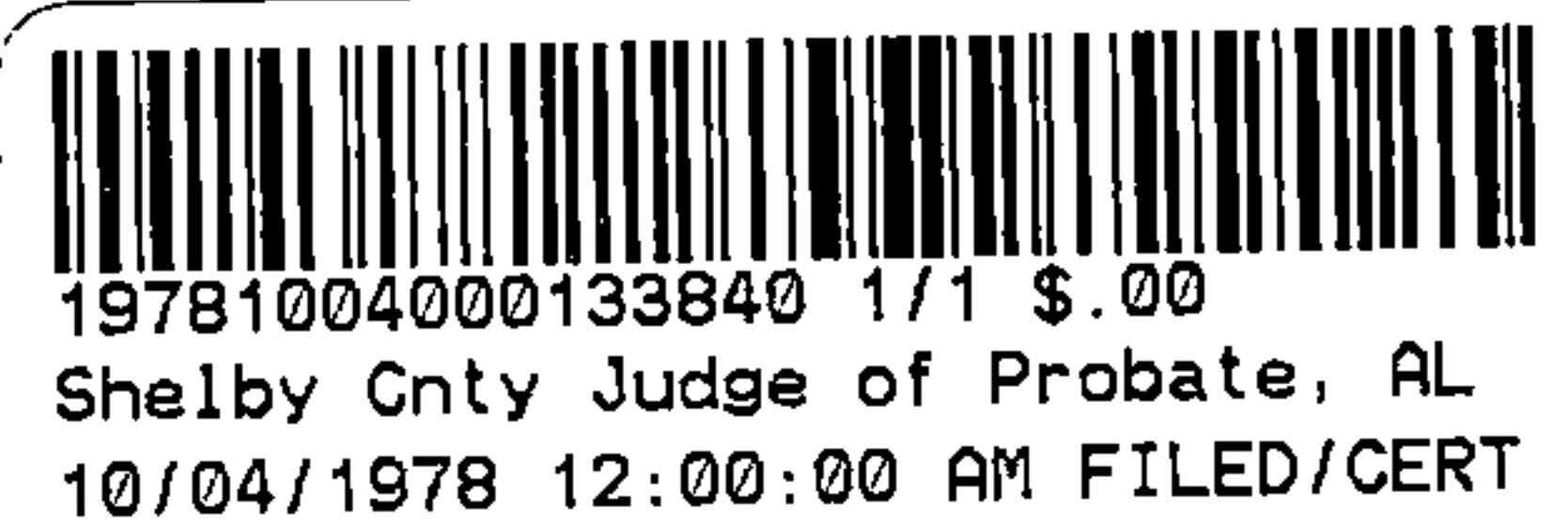

PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: That City Bank of Childersburg, a Corporation being the owner of that certain mortgage by Charles B. Commence at the Northwest corner of the S.E. 1/4 of the S.E. 1/4 of Section 3, Township 20 South, Range 2 East, Shelby County, Alabama, thence Southerly along the West line of said quarter-quarter 39.24 feet to the point of beginning of the property being described, thence continue along last described course 267.25 feet to a point, thence 90 degrees 49 minutes left 678.92 feet to a point, thence 89 degrees 27 minutes left 60.0 feet to a point, thence 89 degrees 27 minutes right 60.0 feet to a point, thence 89 degrees 27 minutes left 207.25 feet to a point, thence 90 degrees 33 minutes left 737.65 feet to the point of beginning, being marked on the corners with iron pins as shown on the plat.

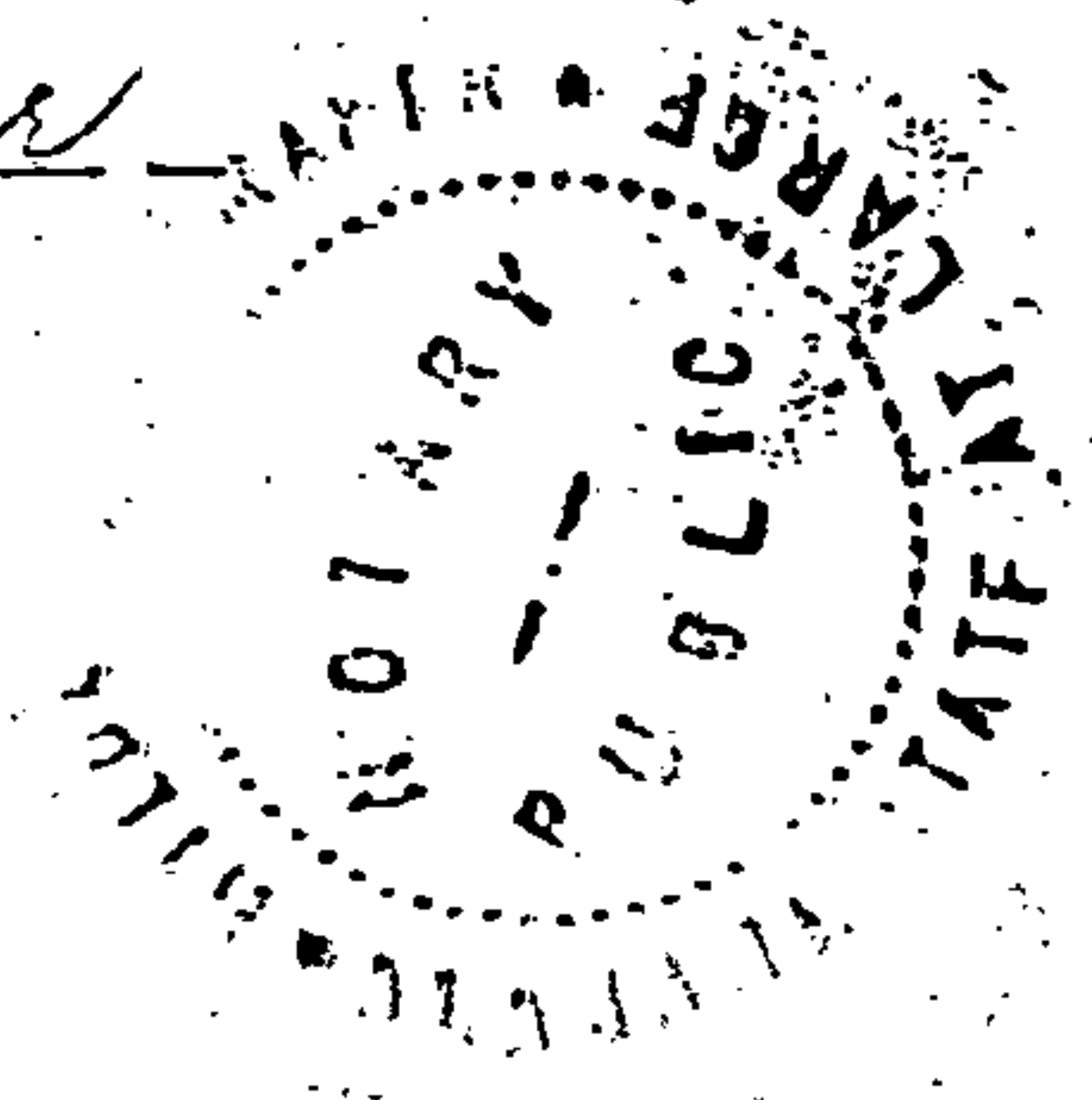
