operate and maintain, along a route to be selected by the grantee, (generally shown
crosshatched on the attached drawing) its successors and assigns, all conduits,
cables, transclosures and other appliances and facilities useful or necessary in
connection therewith, for the underground transmission and distribution of electric
power and for underground communication service, upon, under and across the following
described land situated in Shelby County, Alabama:

A part of the Southwest quarter of the Northwest quarter and the Southeast
quarter of the Northwest quarter and the Northwest quarter of the Southwest quarter
of Section 1, Township 19 South, Range 2 West, Shelby County, Alabama, being more
particularly described as follows: Commence at the Southwest corner of the Southwest
quarter of the Northwest quarter of Section 1, Township 19 South, Range 2 West and run
East along the South line of said quarter-quarter section 799.83 feet to the point of
beginning of parcel herein described; thence turn an angle right of $96^{\circ} 03'50''$ and run
Southwesterly 262.7 feet; thence left $62^{\circ}21'20''$ and run Southeasterly 262.7 feet; thence
left $62^{\circ}21'20''$ and run Southeasterly 292.55 feet; thence turn $100^{\circ}49'$ left and run South-
easterly 231.11 feet to the Northwesterly right-of-way of Valleydale Road; thence left
 $79^{\circ}11'$ and run Northeasterly along the Northwesterly right-of-way 113 feet; thence left
 90° and run Northwesterly 52 feet; thence right $24^{\circ}00'$ and run Northwesterly 82.5';

TO HAVE AND TO HOLD the same to the said Alabama Power Company, its successors and assigns, forever.






