AMENDMENT OF DECREE

It being called to the Court's attention that when the
above case was originally filed, Henry Peoples, Sr. was listed as
a plaintiff in said case;

Whereas, all testimony and proof showed that the true owners
of said property and proper plaintiffs were: Gollie Mae Reese,
Otis Reese, Lizzie C. Peoples, Irene Davis and Thelma Reese McKnight.

It is therefore, ORDERED, ADJUDGED and DECREED by the
Court that the decree filed in this cause on the 19th day of
October, 1978, be and the same is hereby amended as follows:

By deleting Paragraphs 3 and 5 from said decree and in-
serting in lieu thereof, the following:

"3. That the plaintiffs, Gollie Mae Reese, Otis Reese,
Lizzie C. Peoples, Irene Davis and Thelma Reese McKnight, are the
owners of said lands described in said complaint and have an absolute
fee simple title thereto, free of all liens or encumbrances, except
the lien for non-delinquent ad valorem taxes, and plaintiffs' title
to said land is hereby established and all doubts and disputes con-
cerning the same are hereby cleared up, said property situated in
Shelby County, Alabama, and more particularly described as follows:

W $\frac{1}{2}$ of the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 36, Township 20,
Range 3 West, Shelby County, Alabama.

5. A certified copy of this decree be recorded in the
Office of the Judge of Probate of Shelby County, Alabama, and be
indexed in the name of Gollie Mae Reese, Otis Reese, Lizzie C.
