TO HAVE AND TO HOLD UNTO the said Citizens Federal Savings and Loan Association, its successors and assigns, FOREVER.

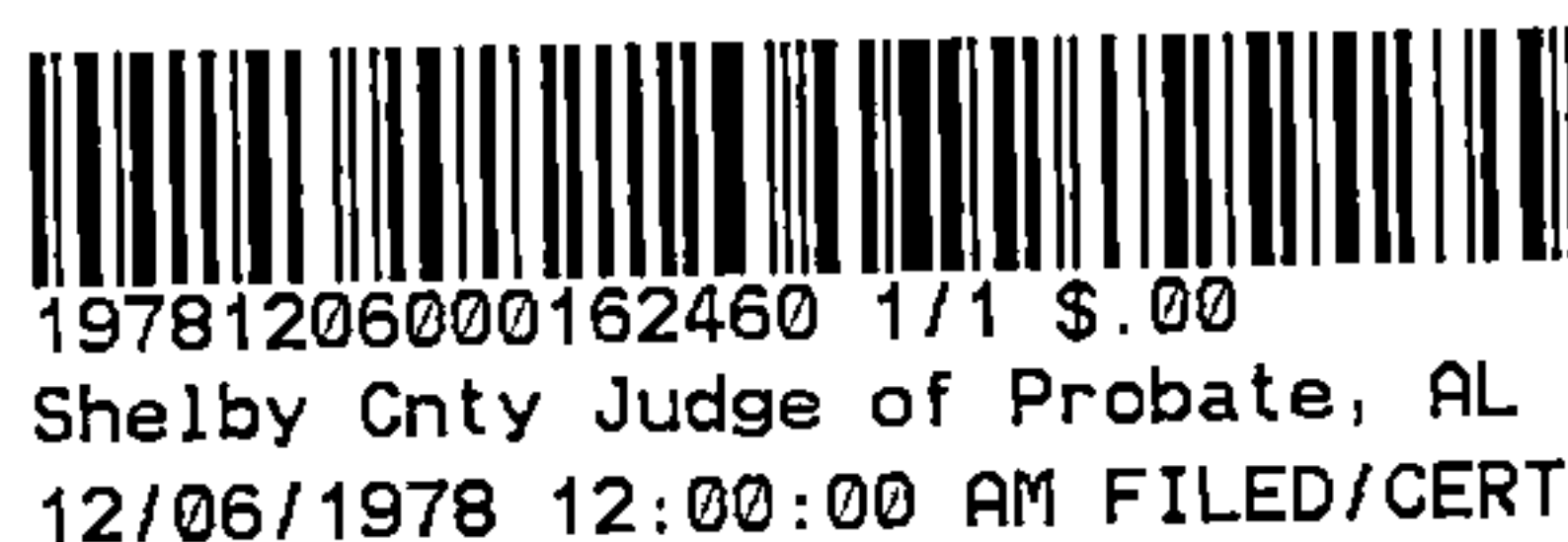
