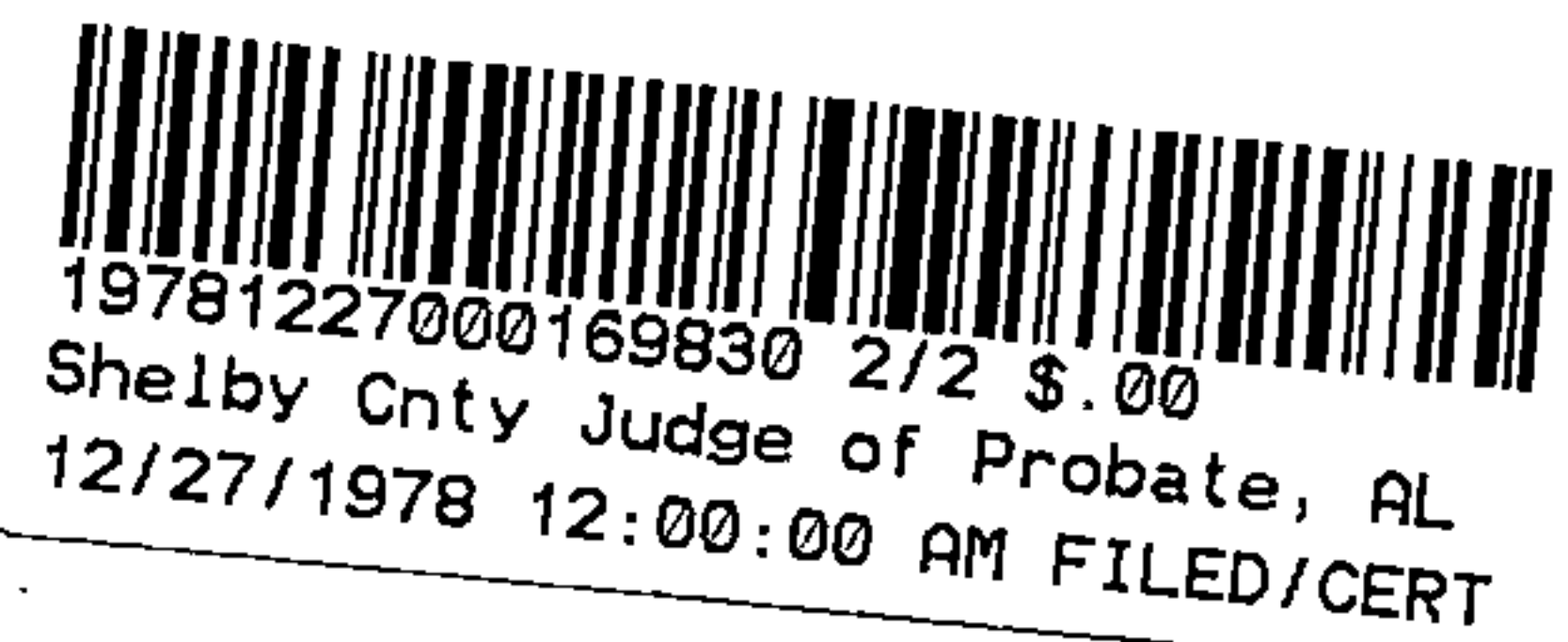

Part of the Northeast quarter of Northwest quarter of Section 2, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

From the western most corner of lot-18 Royal Oaks First Section, a map of which is recorded in the office of the Judge of Probate, Shelby County, Alabama, in Map Book 7, Page 17, looking in a westerly direction along the south line of said quarter-quarter section, turn an angle to the right of 28 degrees 13 minutes 36 seconds and run in a northwesterly direction for a distance of 128.59 feet, thence turn an angle to the left of 5 degrees 20 minutes 30 seconds and run in a northwesterly direction for a distance of 81.00 feet to the point of beginning; thence continue along last mentioned course for a distance of 126.38 feet, thence turn an angle to the right of 64 degrees 14 minutes 30 seconds and run in a northerly direction for a distance of 176.50 feet; thence turn an angle to the right of 90 degrees and run in an easterly direction for a distance of 84.00 feet to a point of beginning of a curve, said curve being concave in a southerly direction and having a radius of 322.61 feet, thence turn an angle to the right and run along the arc of said curve for a distance of 102.57 feet, thence turn an angle to the right and run in southwesterly direction for a distance of 226.66 feet, more or less, to the point of beginning.
