William Barr Livingston and Carol N. Livingston

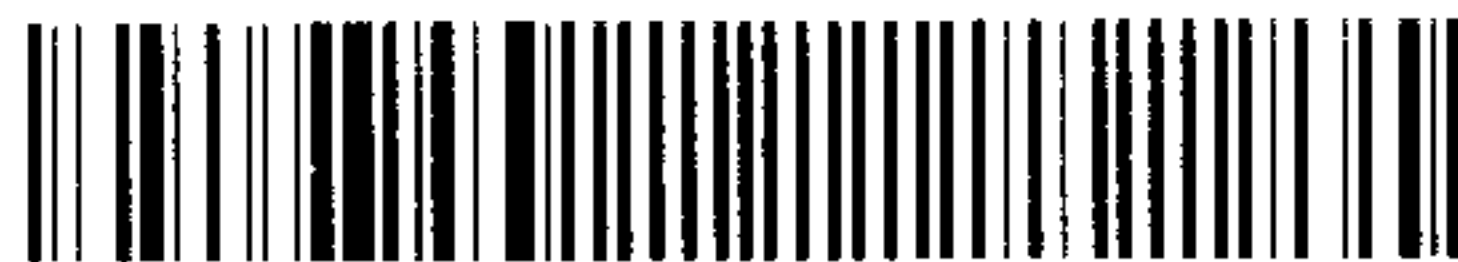
