

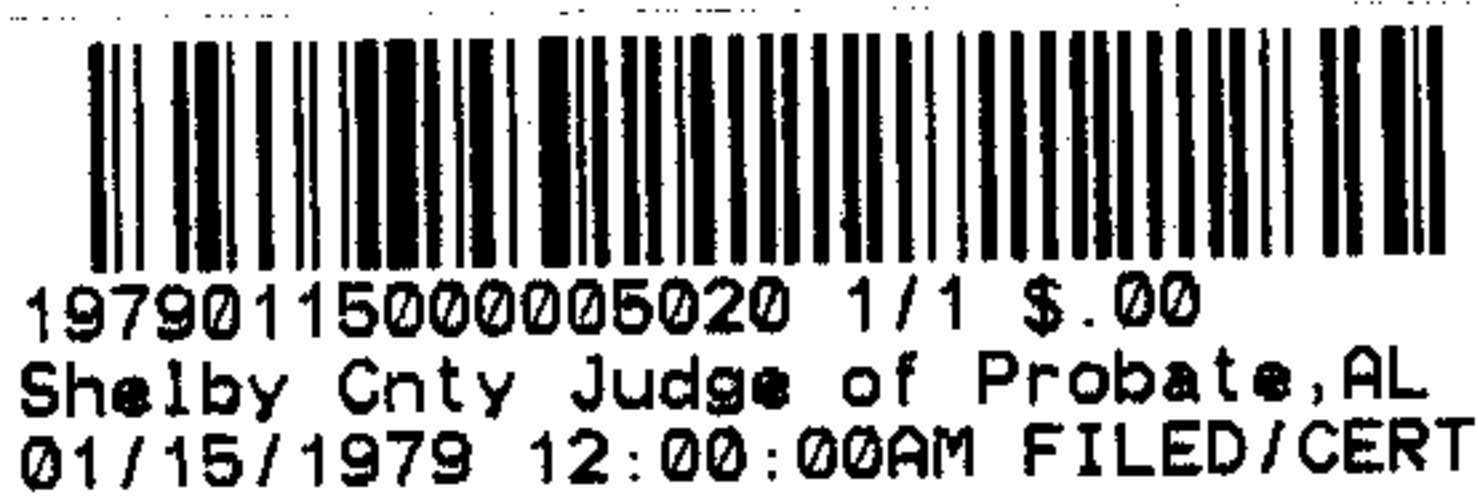

5. Any applicable zoning ordinances.

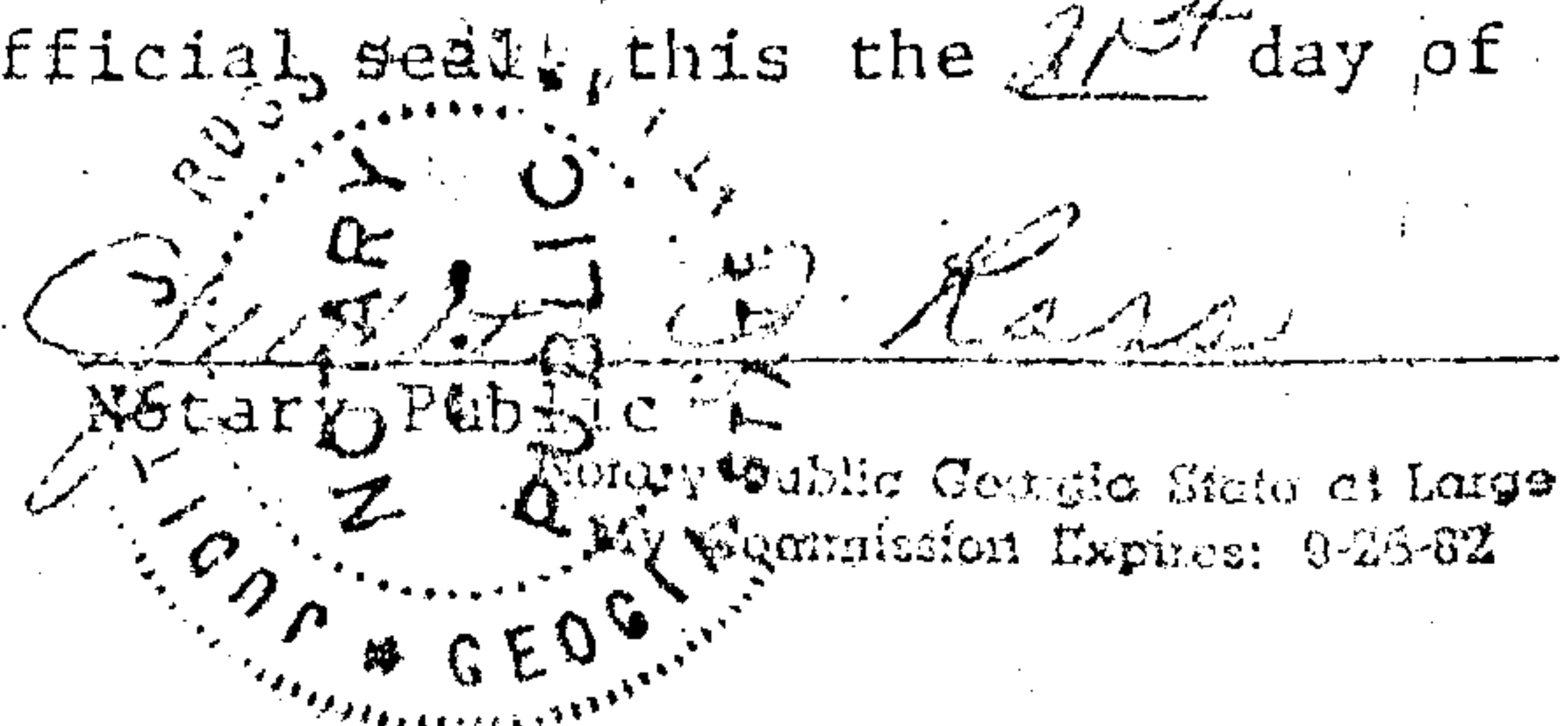
