Alabama, Southern Division, Case No. 78-02184; and,

WHEREAS, subsequent to the filing of said petition on,
to wit: July 31, 1978, the Party of the First Part was duly
elected Trustee of said estate, that he qualified as such Trustee
and entered into proper bond with sureties approved by Honorable
Stephen B. Coleman, Bankruptcy Judge of said Court; that the
Party of the First Part has continued to act and is now acting
and serving as such Trustee; and,

the Party of the Second Part, free and clear of liens and
