this day bargained and sold, and by these presents do hereby grant, bargain, sell and

convey unto the State of Alabama the following described property, lying and being

in Shelby County, Alabama, and more particularly described as

follows: and as shown on the right-of-way map of Project No.
I-65-2(37) as recorded in the Office of the Judge of Probate
of Shelby County, Alabama:

Beginning at the southwest corner of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$,
Section 32, T-19-S, R-2-W; thence S 86° 20' E along the south
line of said Section 32, the south property line, a distance
of 868.23 feet to the northeast property line; thence N 15°
00' W along said northeast property line, a distance of 593
feet; thence N 86° 20' W, a distance of 750 feet, more or less,
to a point that is 200 feet easterly of and at right angles
to the centerline of the right lane of Project No. I-65-2(37);
thence southerly along a curve to the right (concave westerly)
