being in Shelby County, Alabama.

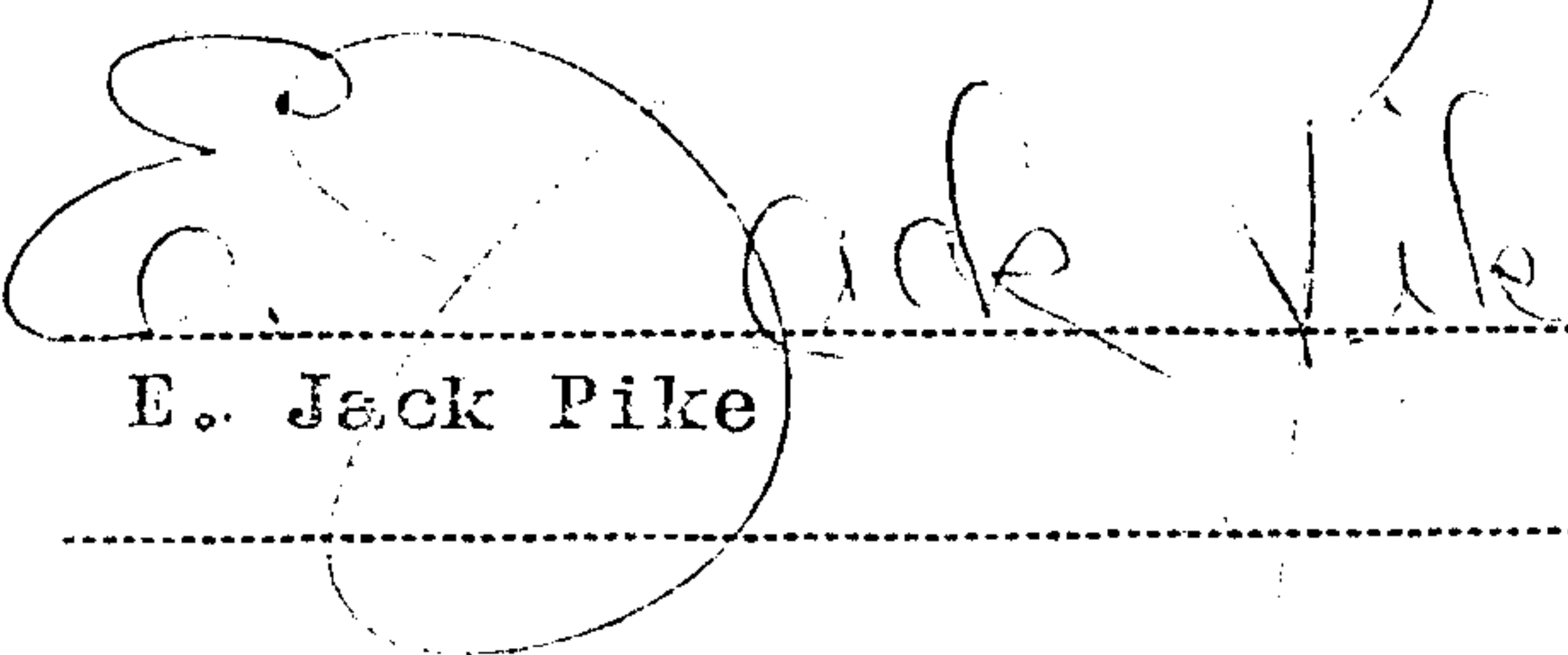
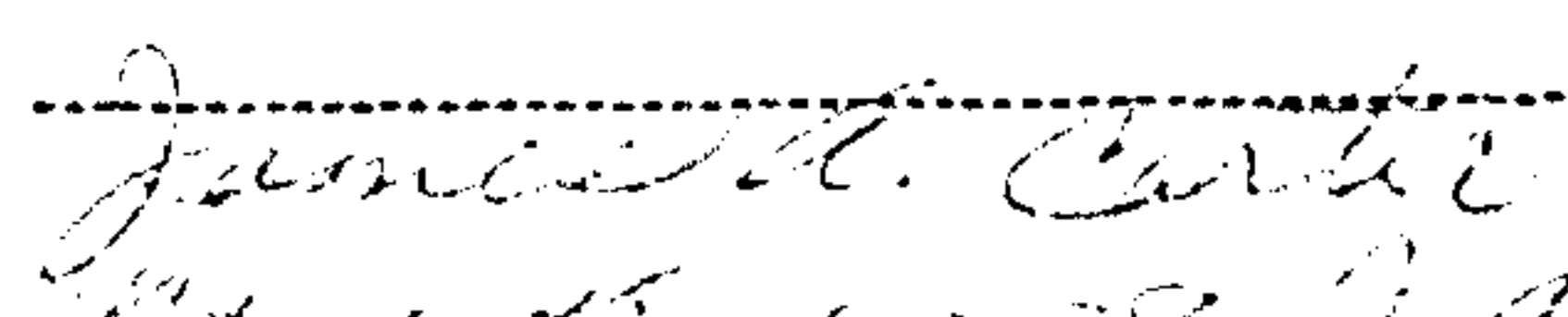
