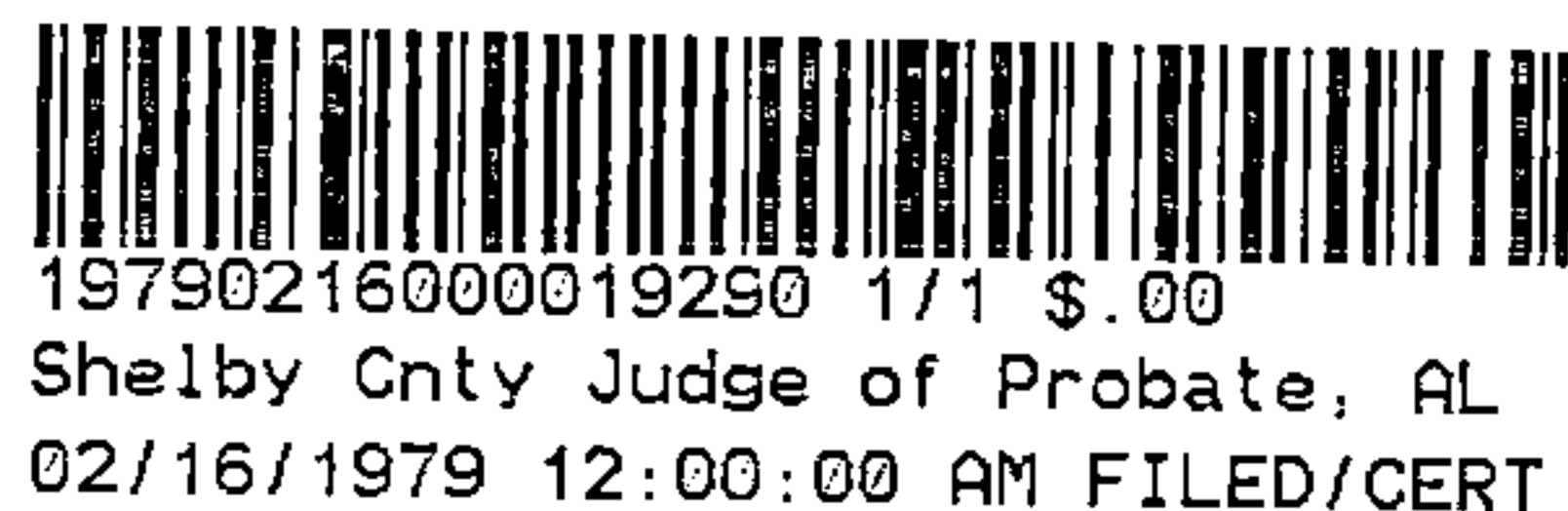


# Satisfaction of Mortgage - Alabama
