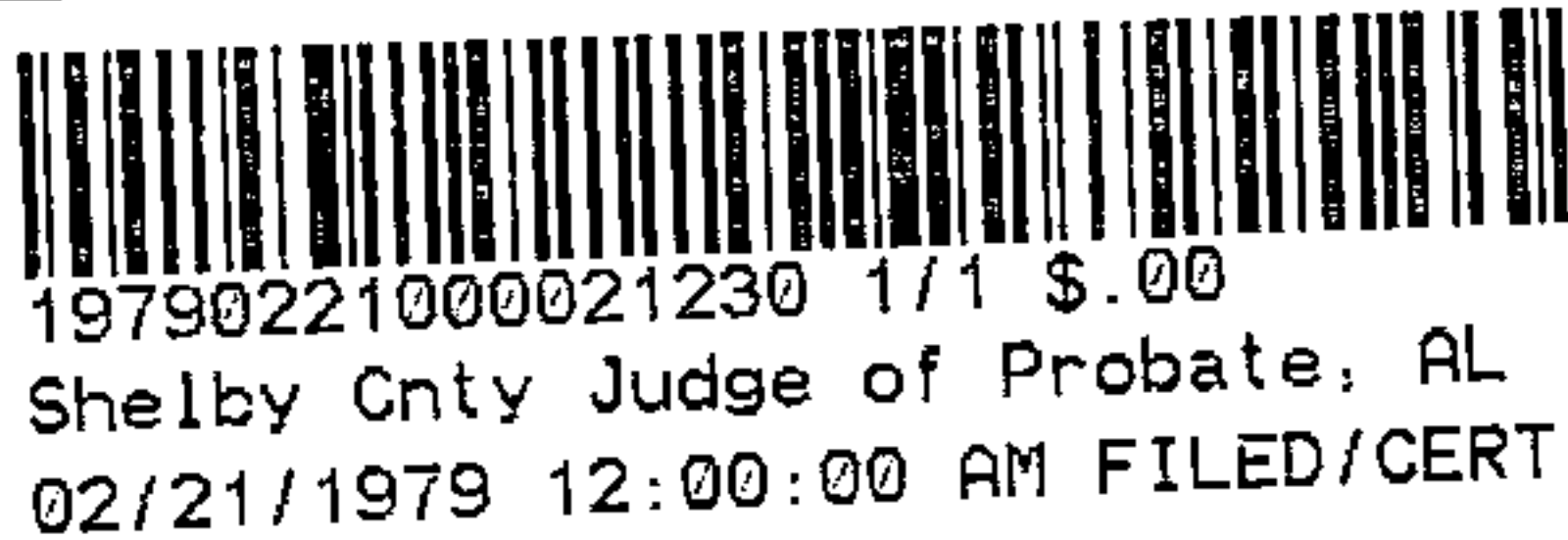


RELEASE FROM LIEN OF MORTGAGE
