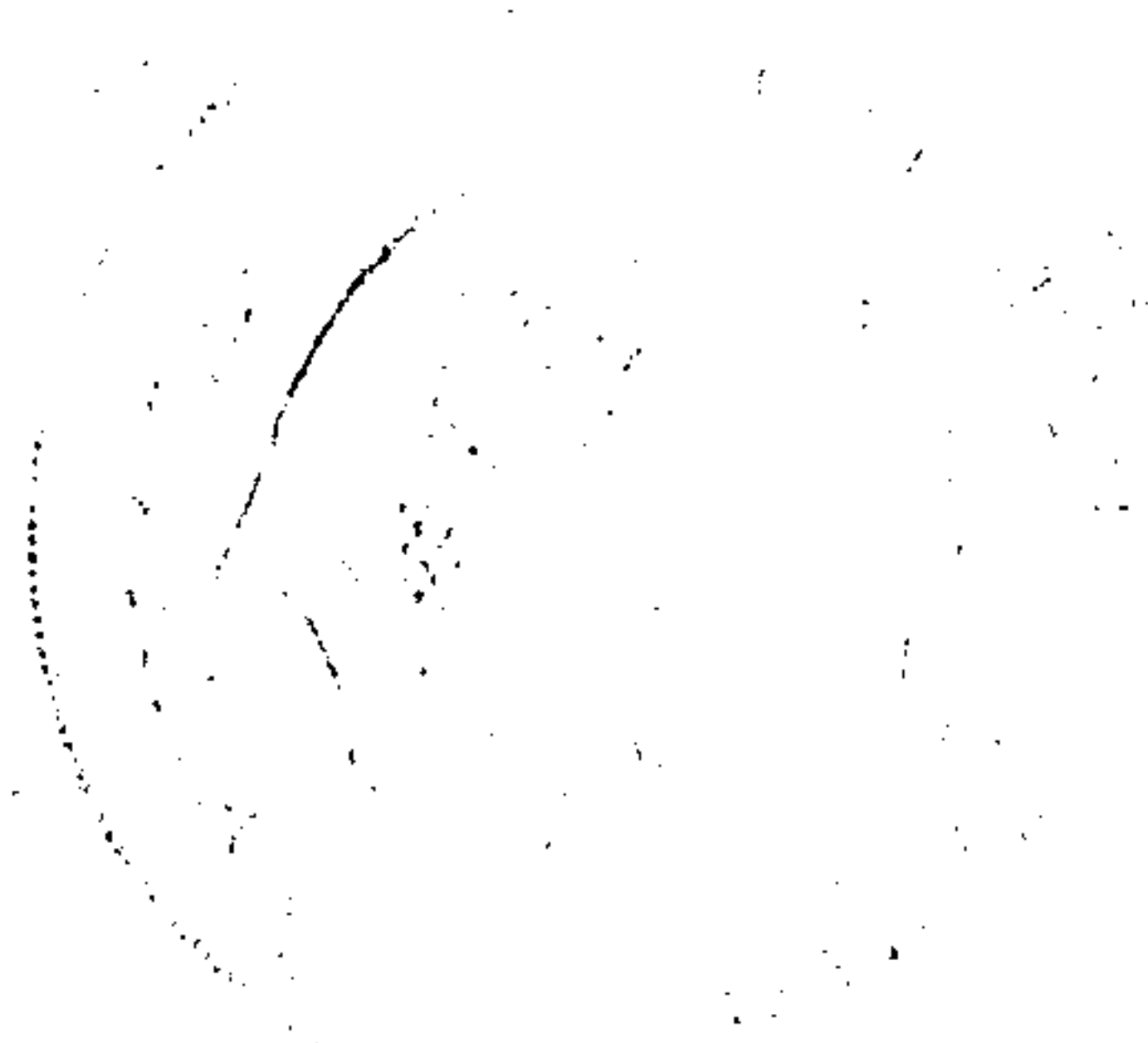
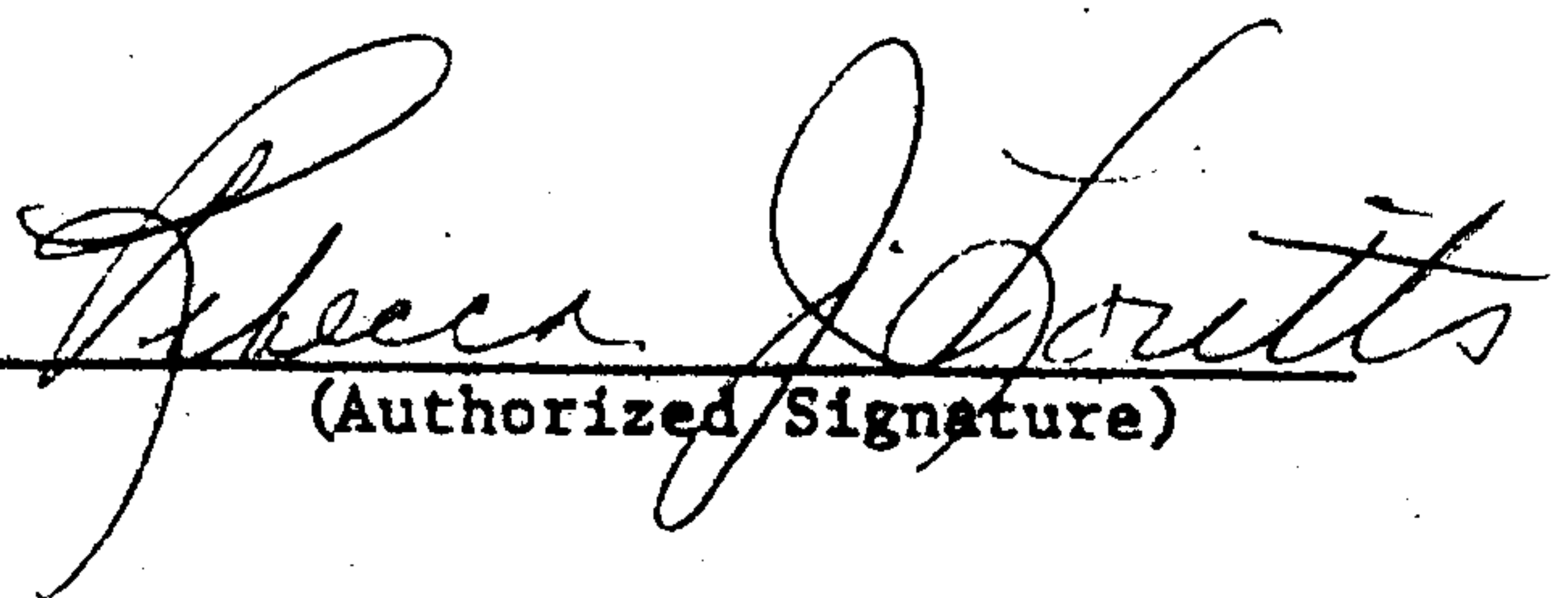

on each side of the Railroad from Montgomery to some point on the Alabama and
Tennessee State line in the direction of Nashville Tennessee, covering thirteen
hundred and sixty four, and sixty eight hundredths (1364.98) acres, within
the State of Alabama, and they are now submitted for the approval of the
Secretary of the Interior in accordance with the requirements of said act of June
