Phillips, do grant, bargain, sell and convey unto Mary Floyd Sanders, Ruby Floyd Cain, Billy Joe Floyd, Louise Floyd Huffstutler, Bobby Floyd Glenn, Mary Helen Floyd Halfacre and Jo Ellen Floyd Levan, the following described real estate situated in Shelby County, Alabama, to-wit:

Begin at the SW corner of Lot #14 in Buck Creek Cotton Mills Subdivision, certified by A.J. Then continue along the same line running easterly for 21.29 feet, then turn an angle of 86 degrees 48 min 20 sec to the left and run northerly for 5.31 feet then turn an angle of 90 deg 00 min to the left and run westerly for 21.26 feet, then turn an angle of 90 deg 00 min to the left and run southerly for 6.48 feet back to the point of beginning.
