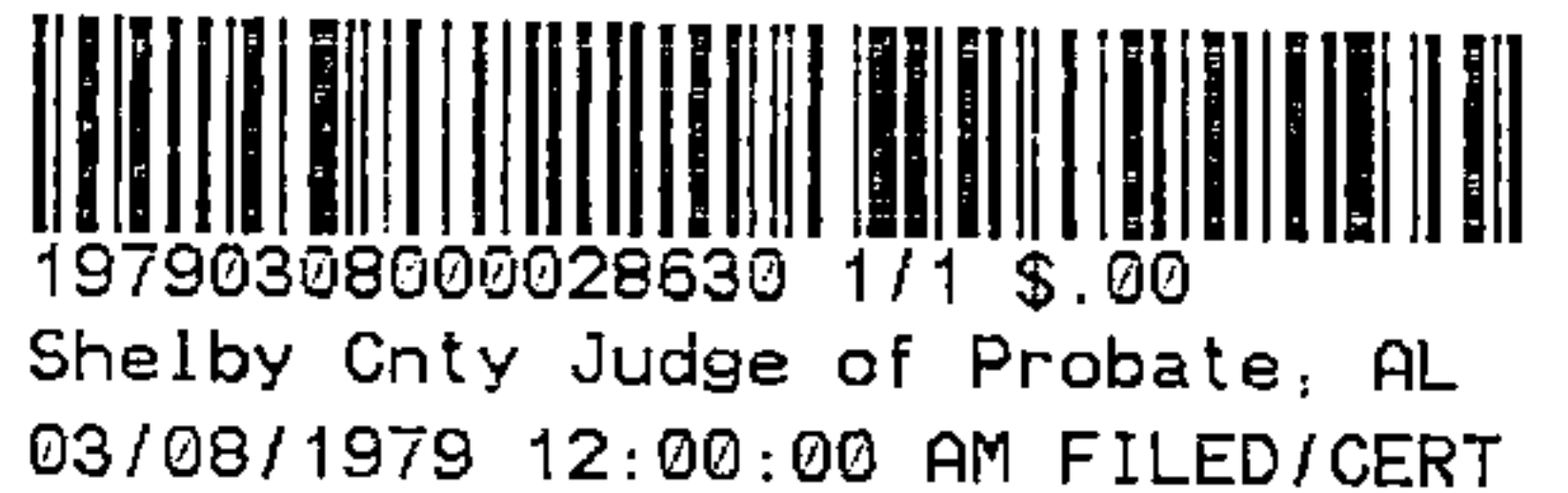


Satisfaction of Mortgage - Alabama
