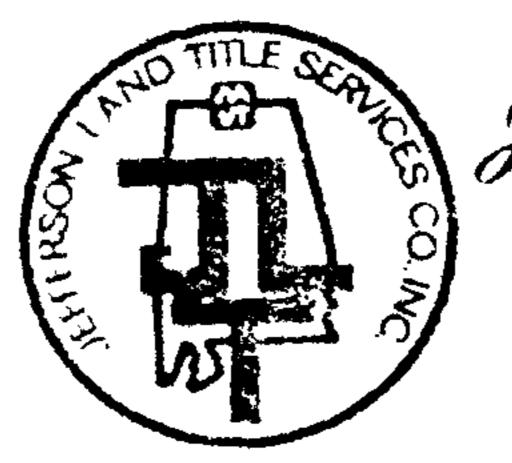

Hewitt L. Conwill and Diane Conwill

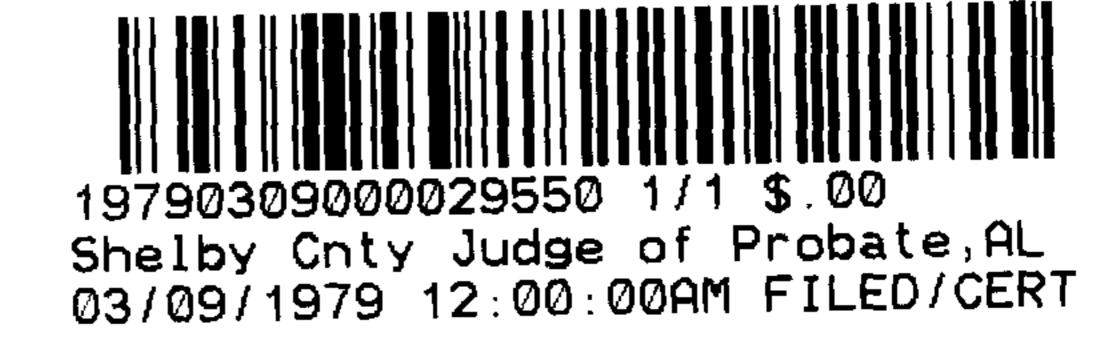
