

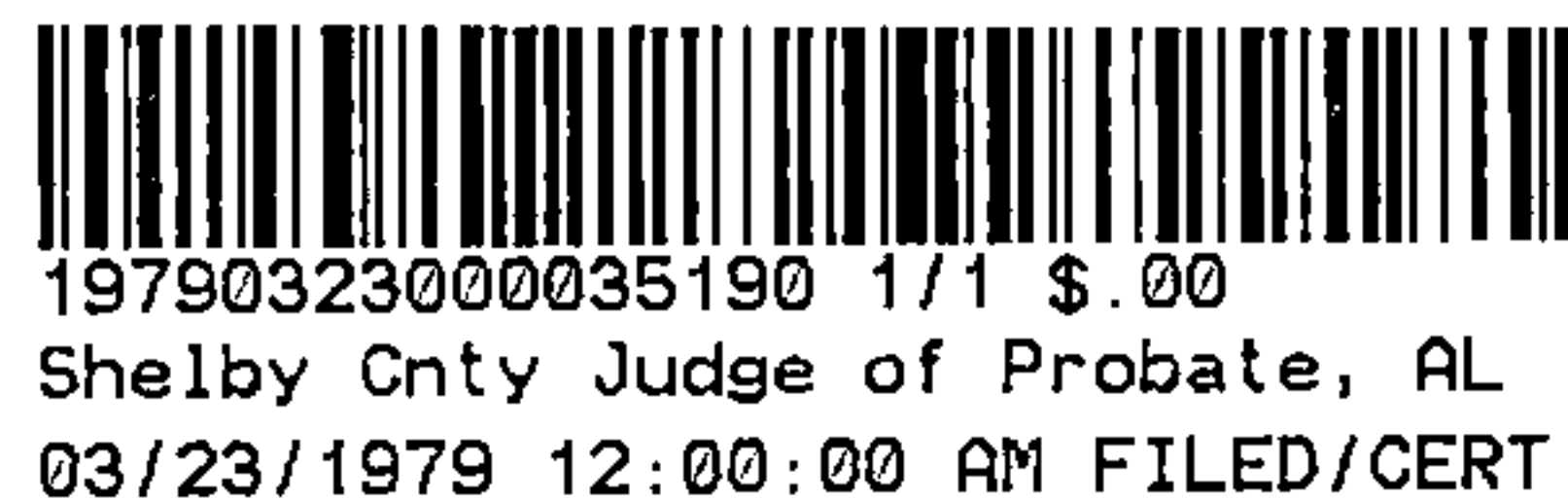
PARTIAL RELEASE
