DECREE

The cause coming on to be heard was submitted upon Plaintiff's Complaint and Answer of Defendant and testimony taken in open court and upon stipulation of counsels' records and the parties, the Court is under the opinion that the Plaintiff is entitled to the relief prayed for in Plaintiff's Complaint. The Court being satisfied from all the testimony that there exists such a complete incompatibility of temperament that the parties can no longer live together, it is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the plaintiff and the defendant be and the same here are hereby dissolved and the said Roberta Vanderslice is forever divorced from the said Oce Vanderslice for and on account of incompatibility of temperament between the parties.

It is further ordered, adjudged and decreed that the plaintiff is awarded a 1/2 interest with right of survivorship and with right of survivorship to the defendant in the house and real property on which the house is located and in which the parties lived as husband and wife in Shelby County, Alabama, and the defendant is ordered to execute the deed to the plaintiff for said real property and should he fail to do so within sixty (60) days the Clerk of this Court is hereby ordered and empowered to convey the defendant's interest in the property to the plaintiff as provided for herein.

It is further ordered, adjudged and decreed that the plaintiff shall receive a 1/2 interest in the unpaid balance of a certain note and mortgage on the following described real estate:

Lots 17, 18, 19, 20, 21 and 22, Block 70, according to Safford's map Town of Shelby, dated 1890 and recorded in the Probate Office of Shelby County, Alabama,

It is further ordered, adjudged and decreed that the defendant shall have the option of paying to the plaintiff Four Thousand Five Hundred Dollars (\$4,500.) within one year from the date of this decree as compensation for her 1/2 interest in the mortgage and note; failing to pay said sum, the defendant is ordered to convey to the plaintiff a 1/2 interest in the note and mortgage of the above-described real estate and that if he fails to do so within one year from the date of this decree, the Clerk of the Court is directed, ordered and empowered to convey a 1/2 interest in the aforesaid property to the plaintiff,

It is a further order and judgment of this Court that the plaintiff is awarded judgment in the amount of Two Hundred Dollars (\$200,00) against the defendant for attorney's fees and that the defendant is taxed with the cost of this action, for which execution may issue according to law,

It is further ordered, adjudged and decreed that neither shall marry again except to each other until sixty days after the date of this divorce decree and if an appeal is taken (which must be instituted within 42 days of this decree or from the date that a post-trial motion is denied), then neither party shall marry again except to each other during the pendency of the appeal,

It is further ordered that the plaintiff and defendant
