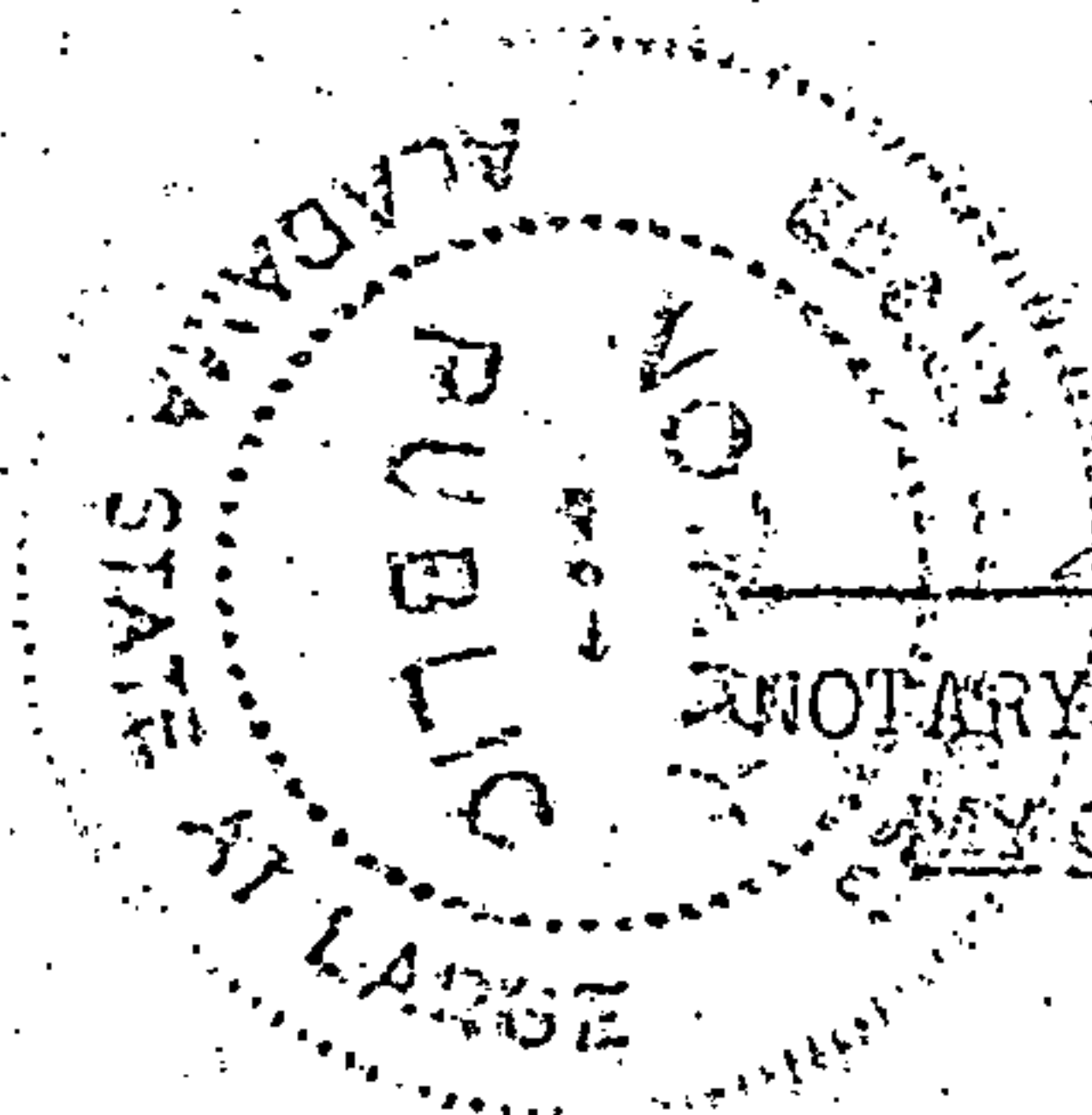

Schedule A

Legal description of the land referred to in this Binder:

A part of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 31, Township 21 South, Range 2 West, more particularly described as follows: Commence at the NW corner of said Section 31, and run thence in an Easterly direction along the Northern boundary of said quarter-quarter section a distance of 50.03 feet to the point of beginning, which point is marked by an iron pipe; thence continue in the same direction along the Northern boundary of said quarter-quarter section a distance of 463.0 feet to a point, which point is marked by an iron pipe; thence turn to the right an angle of 88 deg. 08' and run Southerly a distance of 486.23 feet to a point; which point is on the Northerly right of way line of paved Shelby County Highway; thence turn an angle to the right of 99 deg. 02' and run Westerly along the Northern right of way line of said Shelby County Highway a distance of 468.55 feet to a point which is marked by an iron pipe; thence turn an angle of 80 deg. 58' to the right and run Northerly a distance of 427.6 feet to the point of beginning.
