(herein referred to as GRANTEE(S) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Commence at the Southwest corner of Section 17, Township 22 South, Range 3 West, Shelby County, Alabama; thence Easterly along the South line of said Section 17 568.0 feet to a point; thence 90 deg. 0' left and Northerly 21.0 feet to the point of beginning of the property being described; thence continue Northerly along last described course, 166.0 feet to a point; thence 90 degrees 0' right and Easterly 351.07 feet to a point; thence 132 deg. 16' right and Southwesterly 41.71 feet to a point; thence 2 deg. 24' left and continue Southwesterly 168.40 feet to a point; thence 3 deg. 09' right and Southwesterly 36.77 feet to a point on the South line of said Section 17; thence 46 deg. 59' right and Westerly along the South line of Section 17 151.73 feet to a point on the right of way line of Shelby County Highway No. 206; thence 28 deg. 45' right to chord along a highway curve to the left a chord distance of 44.19 feet to the point of beginning.
