SUPPLEMENTAL INDENTURE OF TRUST

THIS SUPPLEMENTAL INDENTURE of Trust made and entered into this 29TM day of MARCH, 1979, by and between THE INDUSTRIAL DEVELOPMENT BOARD OF THE TOWN OF PELHAM, a public corporation duly organized and existing under the laws of the State of Alabama (hereinafter called the "Borrower") and FIRST ALABAMA BANK OF BIRMINGHAM, an Alabama banking corporation authorized to accept and execute trusts of the character herein set out, with its principal office in the City of Birmingham, Alabama (hereinafter called the "Trustee");

WITNESSETH:

WHEREAS, the Borrower and the Trustee entered into a Mortgage and Indenture of Trust (hereinafter called the "Original Indenture") dated as of February 1, 1979, recorded in the office of the Judge of Probate of Shelby County, Alabama, in Volume 388, Page 767; and

WHEREAS, the Borrower and the Trustee are authorized under
the terms of the Original Indenture to enter into a supplemental
indenture not inconsistent with the terms and provisions of the
Original Indenture without the consent of or notice to any of the
holders of the Industrial Development Bonds issued pursuant to
the Original Indenture, to "cure any ambiguity or formal defect"
in the Original Indenture; and

WHEREAS, the legal description of the real property contained in the Original Indenture was defective;

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS THIS SUPPLEMENTAL INDENTURE WITNESSETH:

That the legal description found on page 11 of the Original Indenture is deleted therefrom in its entirety and substituted therefor is the following legal description to-wit:

Commence at the Northwest corner of the Northeast quarter of the Southwest quarter of Section 12, Township 20 South, Range 3 West and run East along the North line of said quarter-quarter section a distance of 852.44 feet to the point of beginning; thence continue along the last described course a distance of 75.00 feet to a point; thence 89°55' to the right in a southerly direction a distance of 205.20 feet to a point; thence 90°00' to the right in a Westerly direction a distance of 75.00 feet to a point; thence 90°00' to the right in a Northerly direction a distance of 205.30 feet to the point of beginning.

IN WITNESS WHEREOF, The Industrial Development Board of the Town of Pelham and the First Alabama Bank of Birmingham, an Alabama Banking Corporation, have caused these presents to be executed.
