CEMETERY LOT DEED

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of Five Hundred Dollars and No/100 Dollars (\$ 500.00) to the undersigned, J. E. T., Inc., an Alabama corporation (said corporation, and its successors and assigns being herein referred to as "Grantor"), in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the Grantor does by these presents grant, bargain, sell and convey unto

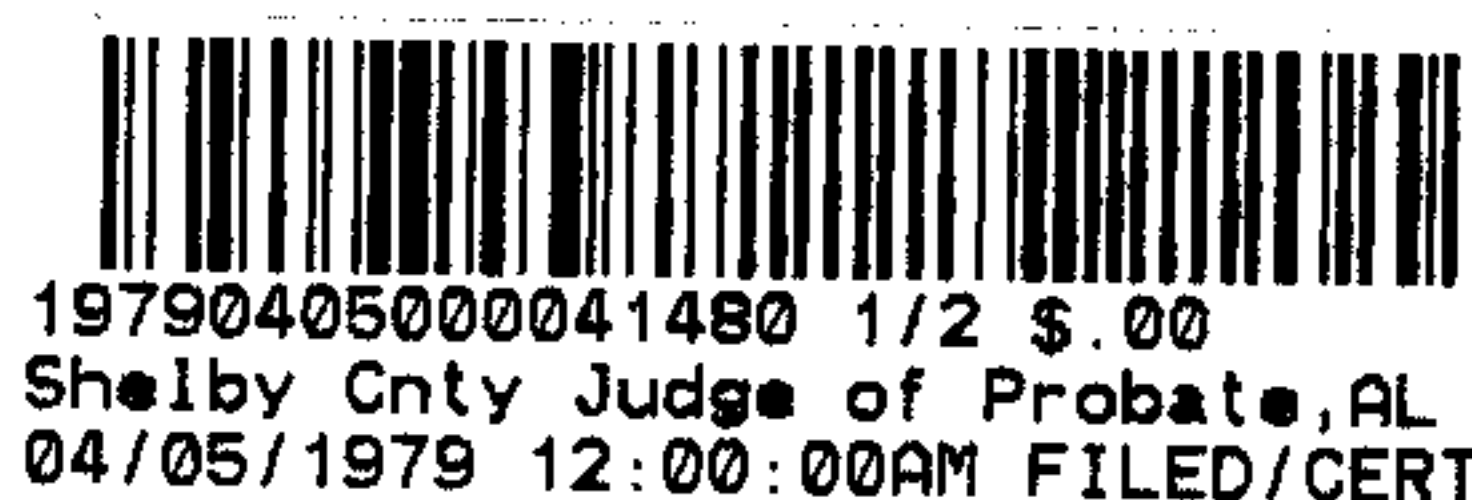
Jean A. Williams

(herein referred to as "Grantees", whether one or more), upon the terms, conditions and provisions hereinafter set forth, a cemetery lot in Fine Lawn Gardens, County of Shelby,

State of Alabama, designated as Lot No. 36 Section 2

Spaces 1 & 2 in Garden of Fountain

Containing 65 square feet, more or less; the same being described and designated as above in accordance with a map on file in the office of said corporation. Said cemetery lot shall be used exclusively for the burial of human bodies, and is sold and conveyed subject to the right of Grantor to supervise, control and regulate the use of same in accordance with Grantor's rules, regulations and bylaws, now existing or hereafter adopted, which such rules, regulations and bylaws are on file in the office of Grantor, and are available for examination upon request. No testamentary disposition shall be made of said cemetery lot by the Grantees hereunder, or by any person who may hereafter acquire any interest in said lot, except by a specific devise in the will of such owner in which said lot is described with certainty.



TO HAVE AND TO HOLD, the above granted cemetery lot to the said Grantees, their heirs and assigns, forever; subject however, to the restrictions and limitations above referred to.

And Grantor, for itself, its successor and assigns, covenants with the said Grantees, their heirs and assigns, that it is lawfully seized in fee simple of said cemetery lot, that it is free from all encumbrances except as herein set forth; that it has a good right to sell and convey the same as aforesaid; and that it will, and its successors and assigns shall, warrant and defend the title to the same to the said Grantees, their heirs and assigns, forever, against the lawful claims of all persons.

Of the above recited consideration such percentage as is provided by the Trust Agreement of Grantor shall be held by Grantor for and on behalf of the Trustees of the Perpetual Care Fund — J. E. T., Inc., and Grantor agrees to pay such sums over to said Trustees as part of said Care Fund to be held by them in trust in accordance with the provisions for said trust set out in the Trust Agreement of Grantor, and for the uses and purposes therein stated, it being provided therein that said Care Fund shall be invested and re-invested by said Trustees, or their successors, and that the interest and income arising from said investment and re-investment shall be expended under the supervision of said Trustees for the maintenance, upkeep and improvement of Grantor's Cemeteries and of the lots in said Cemeteries.

IN WITNESS WHEREOF, the Grantor, J. E. T., Inc., has caused this deed to be executed by its duly authorized officer this 25 day of March, 1979.
