(herein referred to as GRANTEE, whether one or more), the following described real estate, situated in

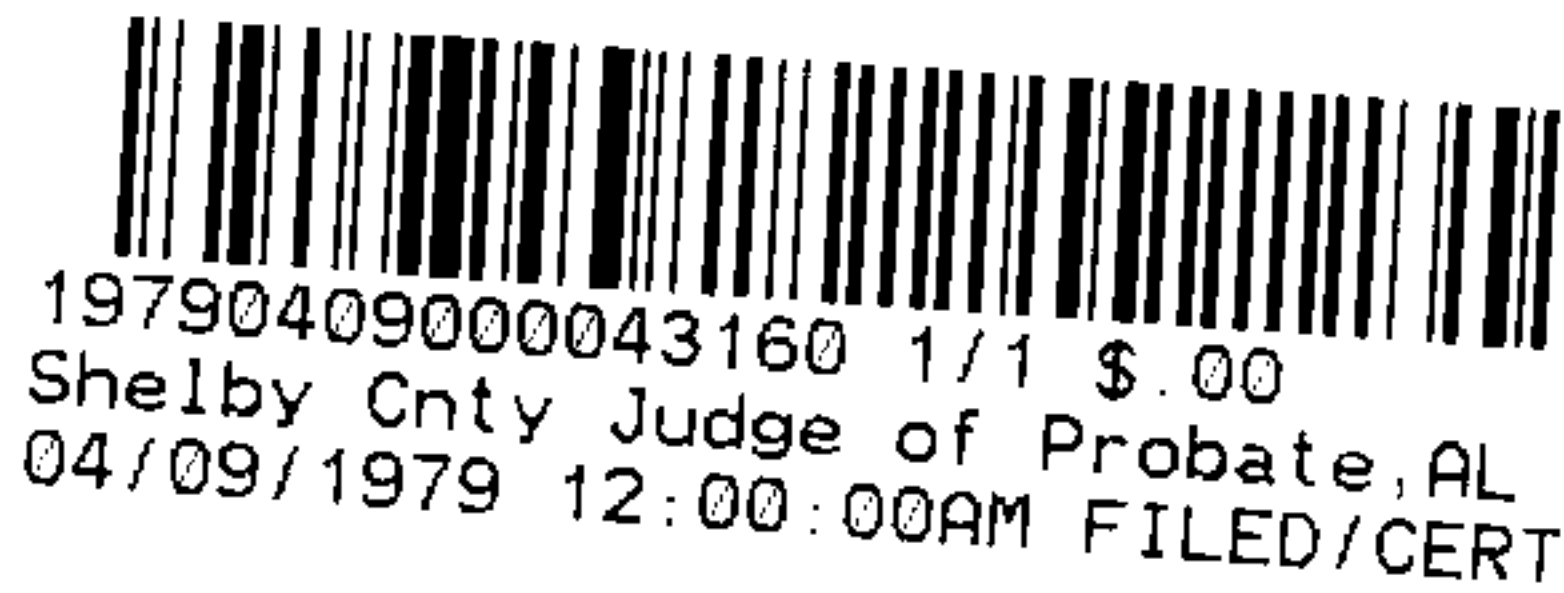
