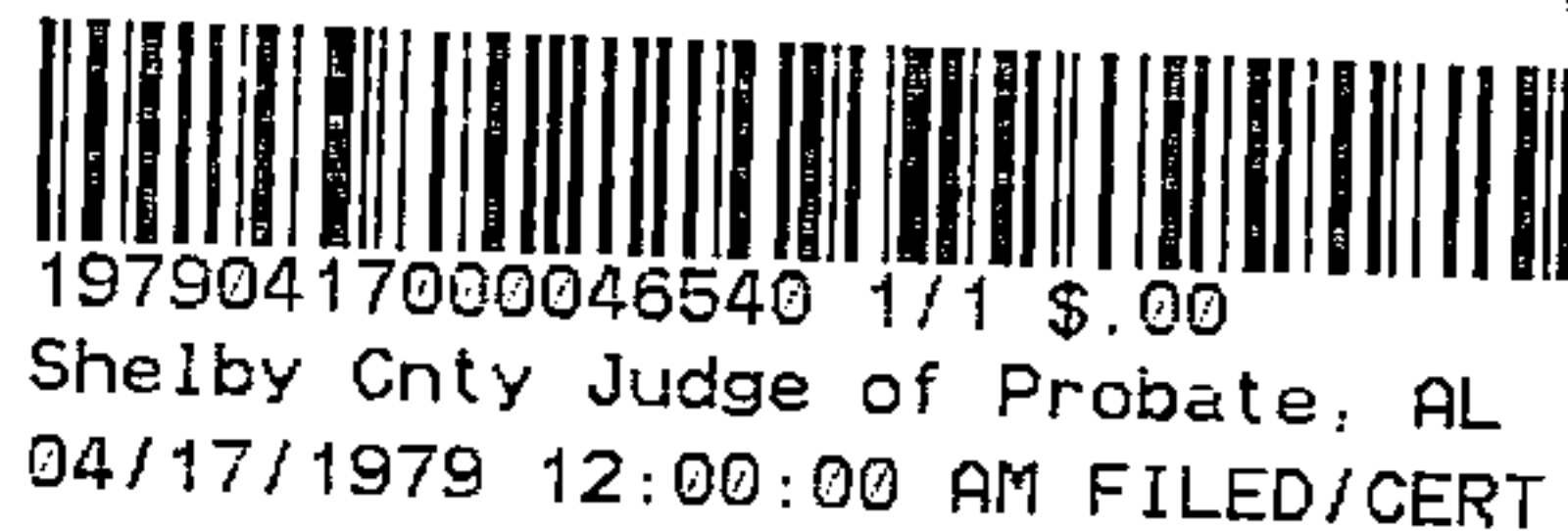


## TRANSFER OF MORTGAGE
