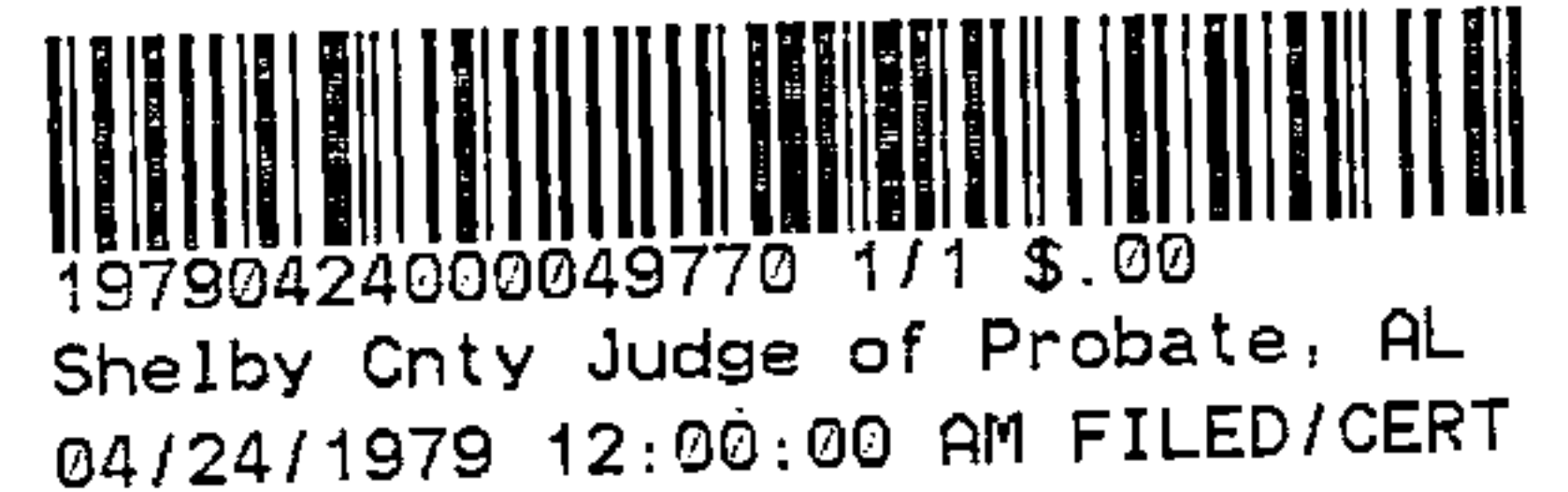


## ASSIGNMENT OF REAL ESTATE MORTGAGE

and all its right, title, and interest in and to the premises situated in the County of Shelby, State of Alabama, and described in said mortgage as follows, to-wit:

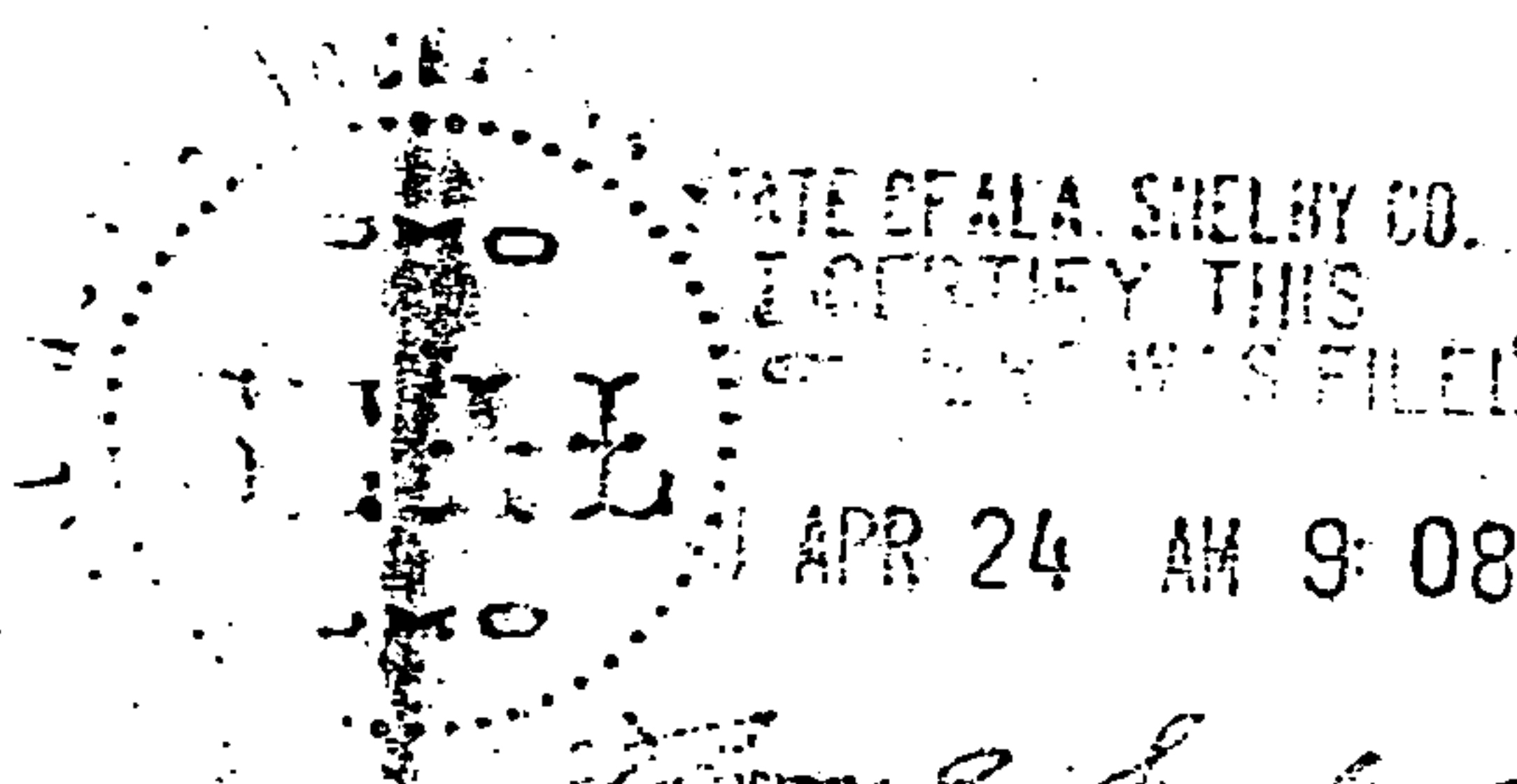
