Whitfield, recorded in Book 365, Page 549, Office of the Judge of Probate, Shelby County, Alabama, described as follows:

Said property is more particularly described as follows:

Commence at the NE corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 33, Township 18 South, Range 2 East, Shelby County, Alabama, and run in a Westerly direction along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 1258.90 feet to a point; thence deflect 90 degrees 00' 00" to the left and run in a Southerly direction a distance of 667.28 feet to a point on the East right-of-way line of a county road, which point is the point of beginning; thence deflect 77 degrees 03' 00" to the left and run in a Southeasterly direction a distance of 290.00 feet to a point; thence turn an interior angle of 90 degrees 00' 00" and run to the right in a Southwesterly direction a distance of 150.00 feet to a point; thence turn an interior angle of 90 degrees 00' 00" and run to the right in a Northwesterly direction a distance of 290.00 feet to a point on the East right-of-way line of said county road; thence turn an interior angle of 95 degrees 41' 30" to the tangent of a curve to the right, having a radius of 756.20 feet, a central angle of 11 degrees 23' 00", and an arc length of 150.25 feet, and run to the right in a Northeasterly direction along said right-of-way line a distance of 150.25 feet to the point of beginning of the herein described parcel; containing 1.01 acres, more or less.
