PARTRIDGE; MARGIE CARR and husband, DOUGLAS CARR; MELBA WHITEHEAD and husband, RAYMOND F. WHITEHEAD; SHIRLEY KELLEY and husband, WILLIAM G. KELLEY; JERRY WAYNE PARTRIDGE and wife, DEBRA PARTRIDGE: MARY JO BRASHER and husband, JOHNNY BRASHER; Claude Partridge being the widower of Flora Partridge, deceased, who died in December of 1962; and Margie Carr, Melba Whitehead, Shirley Kelly, Jerry Wayne Partridge and Mary Jo Brasher being the only children and sole heirs and next of kin of Flora Partridge, deceased, (herein referred to as grantors) do grant, bargain, sell and convey unto JOHNNY BRASHER and wife, MARY JO BRASHER (herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:




