

JUDGE OF PROBATE

All of that part of the NE 1/4 of SW 1/4 of Section 30, Township 18S, Range 1W, which lies south and east of center line of public county road, said property being more particularly described as follows:

Begin at the Southeast corner of the Northeast 1/4 of the Southwest 1/4 of Section 30; Township 18 South; Range 1 West and run West along Quarter line Efor a distance of 860.67 feet; thence turn an angle to the right 122° 59' and Zrun along center line of county road for a distance of 364.90 feet; thence turn an angle to the right 5° 57' and run along center line of county road a distance of 196.67 feet; thence turn an angle to the right of 5° 23' and run along center line of county road a distance of 88.40 feet; thence turn an angle to the left 22° 16' and run along center line of county road a distance of \$64.00 feet; thence turn an angle to the right 7° 38' and run along center Time of county road a distance of 165.60 feet; thence turn an angle to the right 7° 52' and run along center line of county road a distance of 98.40 feet; thence turn an angle to the right 10° 42' and run along center line of county road a distance of 122.48 feet; thence turn an angle to the right 19° 27' and run along center line of county road a distance of 38.40 feet; thence turn an angle to the right 27° 16' and run along center line of county road a distance of 37.65 feet; thence turn an angle to the right 9° 10' and run along center line of county road a distance of 130.93 feet; thence turn an angle to the right 40° 29' and run south along quarter line a distance of 30.3 feet to a 2" capped iron pipe; continue south along quarter line for a distance of 836.6 feet to the point of beginning.
