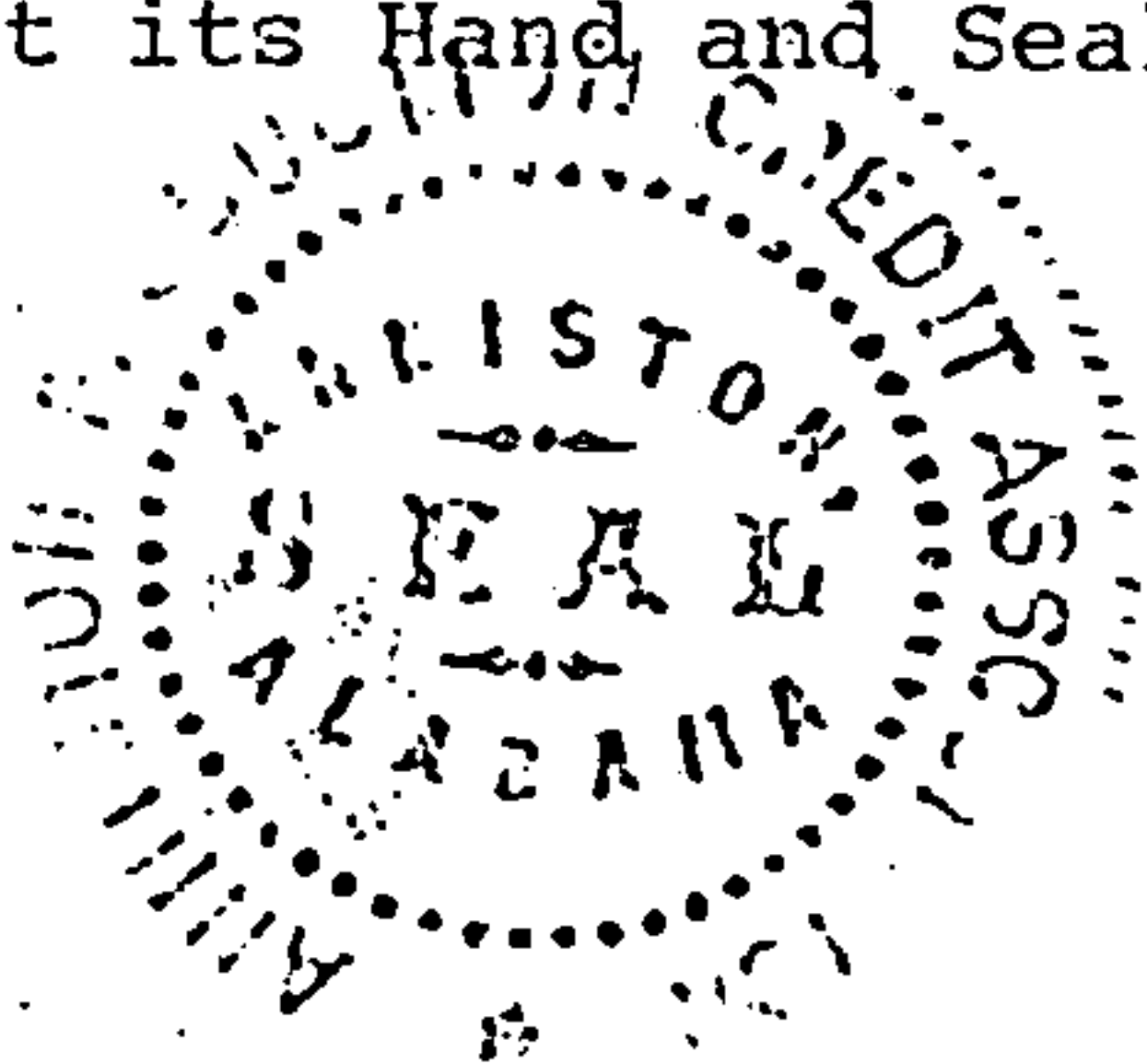
Easement for Driveway

Easement for driveway described as: Ten feet on either side of centerline described as follows:

Commence at the northwest corner of the southwest  $\frac{1}{4}$  of the southeast  $\frac{1}{4}$  of section 36, T-21-S, R-3-W, thence 230 feet along the north line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section, thence an angle of 87 degrees-17'48" to the right for a distance of 278.77 feet to the point of beginning of the centerline of driveway, thence an angle of 56 degrees 38'-45" to the left for a distance of 102.55 feet, thence an angle of 18 degrees 35'-35" to the left for a distance of 226.19 feet, thence an angle of 34 degrees 41'-50" to the left for a distance of 119.13 feet, thence an angle of 11 degrees 19'-20" to the right for a distance of 640.68 feet to a point on the west right of way of Shelby County highway #107 and point of ending of easement for driveway. Situated in the southwest  $\frac{1}{4}$  of the southeast  $\frac{1}{4}$  of section 36 T-21-S, R-3-W in Shelby County.

It being distinctly understood that all the other terms and provisions, shall remain in full force and effect. This instrument shall not be construed to release any property other than the above described real estate.
