That portion of the SE% of SE% lying East of the B.B. &B Branch of the Southern Railway in Section 5, Township 22, Range 3 West; The S% of the SW% of Section 4, Township 22, Range 3 West, all in Shelby County, Alabama, LESS AND EXCEPT the following described tract of land: Beginning at the Northeast corner of the SE% of the SE% of Section 5, Township 22, Range 3 West, and running West 176 yards to Southern Railroad right-of-way; thence South along said right-of-way 119 yards; thence East 233 yards to the Section line between Sections 4 & 5; thence North along said Section 119 yards to point of beginning, being a part of the SE% of the SE% of Section 5, Township 22, Range 3 West, containing 5 acres, more or less,

together with full and free right of ingress and egress to and from said land at any and all times until the expiration of twelve (12) months from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said timber, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantor herein.

The grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devises as may be necessary or useful to the grantee for the purpose of cutting and removing the timber, however, all roads are to be left in as good condition as at the beginning of this contract.
