

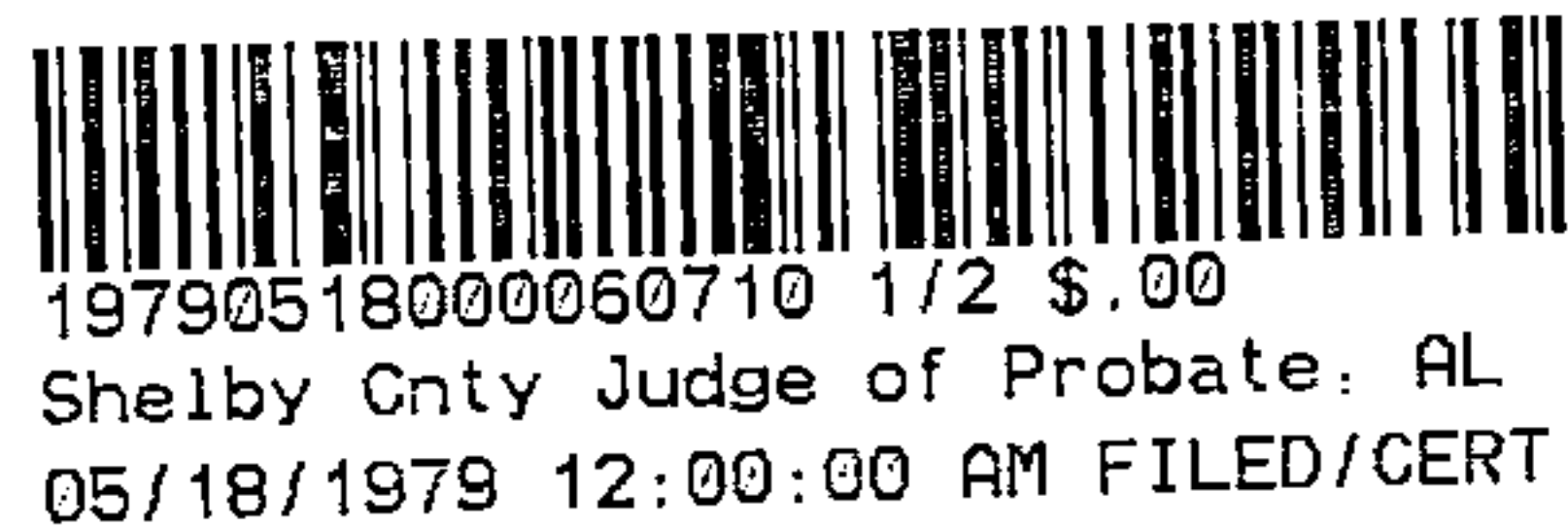

DELEGATION OF AUTHORITY




