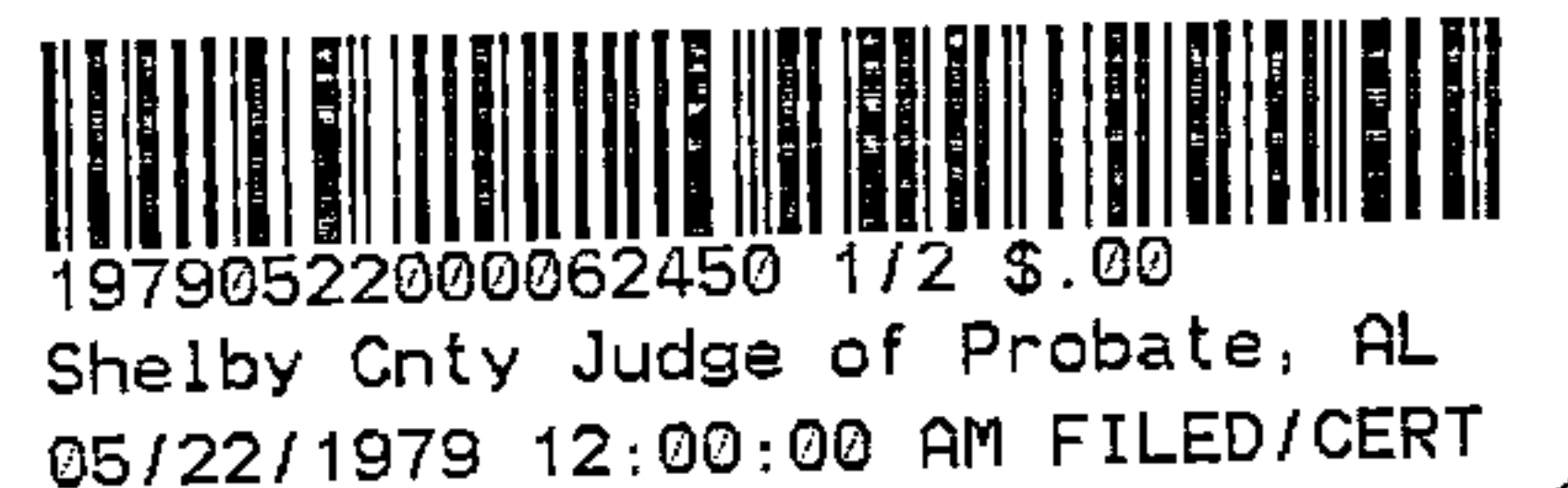

Commence at the Southwest corner of Section 17, Township 22 South, Range 3 West, Shelby County, Alabama, Thence Easterly along the South line of said Quarter-quarter 568.0' to a point, Thence 90 Degrees left and Northerly 187.0' to the point of Beginning of the property being described, Thence continue along last described course 140.0' to a point, Thence 90 Degrees right and Easterly 411.92' to a point, Thence 70 Degrees 37 Minutes right and Southeasterly 55.65' to a point, Thence 61 Degrees 39 Minutes right and Southwesterly 118.24' to a point, Thence 47 Degrees 44 Minutes right and Westerly 351.07' to the point of beginning, containing 1.29 Acres .

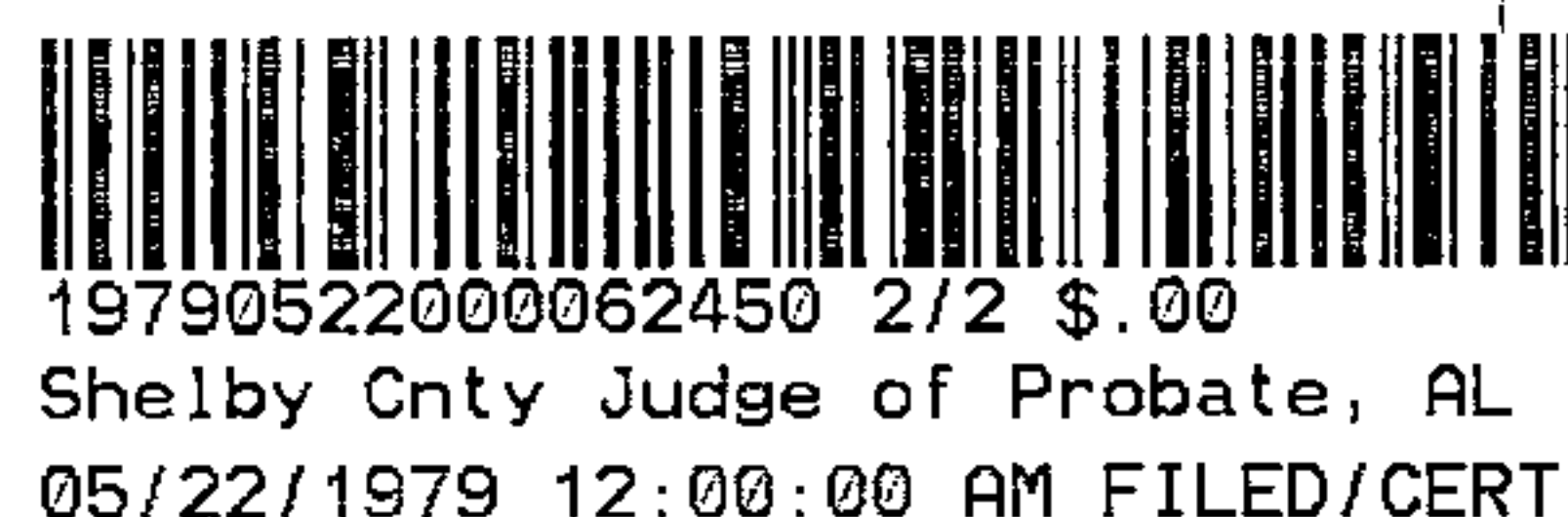

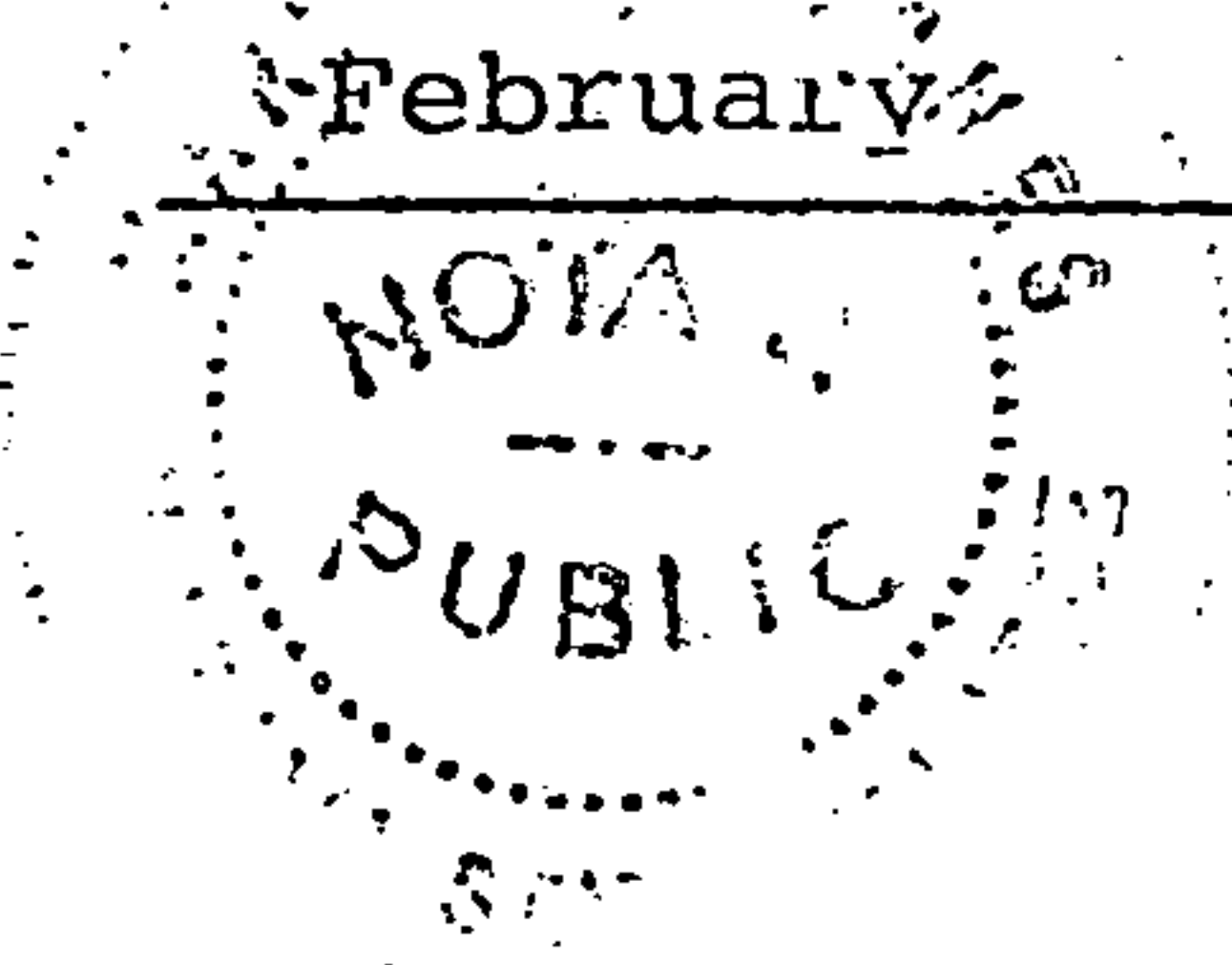
