
WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

STATE OF ALABAMA SHELBY COUNTY



KNOW ALL MEN BY THESE PRESENTS, that in consideration of Twelve thousand five hundred and no/100 ----- DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Will D. Nix and wife, Lorraine Nix; Lydia N. Anderson, a widow; Edgar Roy Nix and wife, Mary Junita Nix; Mack Aron Nix and wife, Lurlene Nix; John W. Nix and wife, Cherry Lou Nix; George Archie Nix and wife, Fay Nix; Lula Mae Sherrer and husband, Bobby E. Sherrer; Peggy Nix, a widow, and James Leon Nix and wife, Betty Joyce Nix

(herein referred to as grantors) do grant, bargain, sell and convey unto

James Edwin Czeskleba and wife, Karen Nix Czeskleba

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described County, Alabama, to-wit: real estate situated in Shelby

Begin at the S.E. corner of the NE% of the SW% of Section 16, Township 22 South, Range 3 West and run Northerly along the East side of the said quarter-quarter for 328.84 ft. to the point of beginning. Then continue along the last described course for 328.84 ft., then turn an angle of 88 deg. 40 min. 39 sec. to the left and run westerly for 1241.17 ft. to a point on the east right of way of Shelby County Road No. 15, then turn an angle to the left and run southerly along the said R.O.W. for 328.44 ft. more or less to a point more particularly described by turning an angle of 91 deg. 28 min. 15 sec. to the left and running southerly along a chord of said R.O.W. for 328.44 ft., then turn an angle of 88 deg. 30 min. 45 sec. to the left and run easterly for 1240.34 ft. back to the point of beginning.

The above described parcel contains 9.36 acres and is subject to the easements, rights of ways,

and restrictions of record.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.
