
WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

(herein referred to as grantors) do grant, bargain, sell and convey unto

Begin at the S.E. corner of the NE¼ of the SW¼ of Section 16, Township 22 South, Range 3 West and run Northerly along the East side of the said quarter-quarter for 328.84 ft. to the point of beginning. Then continue along the last described course for 328.84 ft., then turn an angle of 88 deg. 40 min. 39 sec. to the left and run westerly for 1241.17 ft. to a point on the east right of way of Shelby County Road No. 15, then turn an angle to the left and run southerly along the said R.O.W. for 328.44 ft. more or less to a point more particularly described by turning an angle of 91 deg. 28 min. 15 sec. to the left and running southerly along a chord of said R.O.W. for 328.44 ft., then turn an angle of 88 deg. 30 min. 45 sec. to the left and run easterly for 1240.34 ft. back to the point of beginning.

The above described parcel contains 9.36 acres and is subject to the easements, rights of ways, and restrictions of record.
